#### NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC Rules and Regulations, including, but not limited to, the following:

- This event is held under AAC Rules and Regulations (as of June, 2015) and is open to all dogs being at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance, or dogs showing signs of aggression.
- Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specifications. A breakaway tire will be used.
- No leads, collar, food, or any other aids or devices shall be permitted during a regular run. \*Toys (no food) may be used during FEO runs.
- It is expressly understood that exhibitors alone are responsible for the behaviour of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behaviour may be asked to leave the show grounds. In such cases, no refund of fees will be paid.
- All dogs must be kept in their ex pen or crate or on leash when not in the ring. All dogs must be in control when leaving the ring after their run.
