8.6.1 The authorities of any show may decline to accept entries for just cause.

4.1.5 No person may approach a judge whether directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

Donna Conod My name is Donna Conod and I have been involved in the breeding, handling and showing of many Champions, BIS, BISS and Select German Shepherd Dogs for the past 26 years. I have had exposure to the breed since I was 8 years old but did not start exhibiting and breeding GSD until the early 90 s. I became licensed to judge in 2003. My most prestigious and memorable assignment was judging the German Shepherd Dog Club of Canada s National Specialty in 2014. I have also judged numerous German Shepherd Specialties across the USA and Canada. Balance and soundness top my list as to what I look for in the breed.

While I am considered a specialty judge for both German Shepherds and Great Danes, I am approved to judge All Breeds and have judged in Canada, the USA, Mexico, Australia, Argentina and Finland (critiques required) Other breeds I have owned include Poodles, Shih Tzu, Pharaoh Hound, Dachshund, Wire Haired Fox Terrier, American Cocker and Cairn Terriers.



Laurel Deptuch has been showing/breeding since 1977. She breeds Afghan Hounds and Standard Poodles. She has been judging since 2017.



Dayna Johnston has had a lifetime of involvement in breeding, exhibiting and loving pure bred dogs. Dayna was born into a family who have had a long history with the breeding and exhibiting a variety of breeds including Gundogs and Terriers. Whilst growing up surrounded by English Cocker Spaniels, in 1977 the family branched in to Toy breeds, in particular Australian Silky Terriers and Pomeranians. Dayna still proudly owns, breeds and exhibits Australian Silky Terriers under the Gayplad Kennel prefix, co owned with her mother Pat and sister Tanya, and owns the 2023 NSW Show Dog of the Year. Dayna has also owned Pomeranians and Pekingese

and exhibited English Cocker Spaniels, Pugs and Cavalier King Charles Spaniels. In 1998, Dayna attained her dream of owning and exhibiting a Miniature Poodle. With expert guidance, knowledge and support, Dayna has gone on to exhibit and breed many Australian Champions under the Coifico Kennel Prefix, in partnership with John Edwards. In 1991 Dayna gained her ANKC Toy Group license and is now licensed to judge All Breeds. Dayna has had the honour and opportunity to judge across Australia and overseas, including Singapore, New Zealand, Scotland, Sweden, Norway, Canada, South Africa, and Ireland.



Mark Johnston showed his first Boxer as a child in 1976, and has been actively involved with this fabulous breed ever since. From those early beginnings, Mark became the driving force in the family's interest in Boxers, and Blueprint Boxers have gone on to become one of the most successful kennels in the Australia, with an international reputation. Blueprint Boxers have produced a long line of BIS winners, who have been recognised under top judges from around the world. With an interest in all aspects of the dog game, Mark has been President of the Boxer Club of New South Wales, and is currently the President of the Australian National Boxer Council. Mark has been licensed to judge Boxers since 1998, and All-breeds and award BIS since 2014, judging at many shows throughout Australia and New Zealand, England, Scotland, Ireland, Sweden, Singapore, South Africa, China, Canada, The Philippines, Chile, Norway, and Japan. Mark has travelled extensively around the world to attend major shows,

including Crufts and World Dog Shows leading him to believe in the value of good dogs from anywhere in the world. Mark is married to Dayna, who is a partner in the world famous "Coifico" Miniature Poodle kennel.



Gloria Kerr has bred and titled numerous conformation champions under the name of Krishna Kennels. Several famous USA Golden Kennels are founded on her Krishna dogs. She has bred many champions in Golden Retrievers, Akitas, Pembroke Welsh Corgis and Chinese Crested. Many of these dogs have attained Best In Show and Best In Specialty wins.

Gloria became an AKC licensed professional handler in 1974 and has handled, finished, and specialized dogs in every AKC group.

In 2000 she became an AKC licensed judge and is now approved for the Sporting Group, Herding Group, Terrier Group, Toy Group, Non-Sporting Group, several breeds in the Hound and Working Groups, Junior Showmanship, and Best In Show. She has judged throughout the world in Australia, New Zealand, Korea, Indonesia, Taiwan, China, Canada, Sweden, Columbia, Japan, Germany, Argentina and Brazil, including the Golden Retriever National Specialties in the USA, Korea and Canada, the Chinese Crested National Specialty, the Akita National Specialty and the

Brittany National Specialty in the USA.



Kerry Lee I grew up with dogs and that breed was Bull Terriers . When I went to University I had Weimaraners for 20 years and I also was involved in English Setters and English Pointers. Some 40 years ago I was given by my Grandmother a Wire Fox Terrier as this was her breed and she wanted me to get a "real dog" and so my journey into this breed began which as of today I am still involved with. I have also been involved with Bedlington Terriers, Norwich Terriers and also Kerry Blue Terriers. As I wanted to give something back to the dog world after what it has given me a lifetime of not only enjoyment and some wonderful friendships but the opportunity to have met some people who I once would read about in print and having been able to meet these people in person and from time to time around the world at dog shows sit with them and learn even more about breeds so some of those people became my mentors , sadly some of those great people have passed on but I will always remember our observations at Dog Shows and me learning more and more about dogs . I decided to take up Judging. During this time I have been able to Judge in the United States of America and New Zealand , Thailand ,Ireland, Denmark ,United Kingdom , South Africa, Japan as well as most States in Australia .



Shellie Marshall I am a 3rd generation dog show breeder/ exhibitor who has been involved in many breeds. I started my show career with Weimaraner's and married into Dalmatians and joined the Pampard dynasty winning some of Australia's biggest dog shows including Melbourne Royal Show. I then became involved into Petit and then Grand Basset Griffon Vendeen with great success. My other breeds owned and loved have been English springer Spaniels, Dandie Dinmont Terrier and Dobermans.

I achieved my All Breeds status in 2013 and have been lucky to officiate in all states of Australia, New Zealand, Finland, Denmark, USA, China, Thailand and Indonesia. I am currently the chairman of the Junior Handler Working Party and the Non Sporting Judges training coordinator and have been on the board of Management for Dogs Victoria. I am looking forward to judge at your shows in 2024 and returning to Canada where I lived for 12 months as a Rotary exchange student in Smithers, BC when I was 17.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS - This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE BREED JUDGING** on that day. TCN Fees **WILL NOT** be refunded

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

NON-REGULAR CLASSES

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

BREEDER/OWNER/HANDLER- you must enter this class (no fee) to be considered

SEXUALLY ALTERED

SEXUALLY ALTERED CLASS - This class is for dogs which have been spayed or neutered.

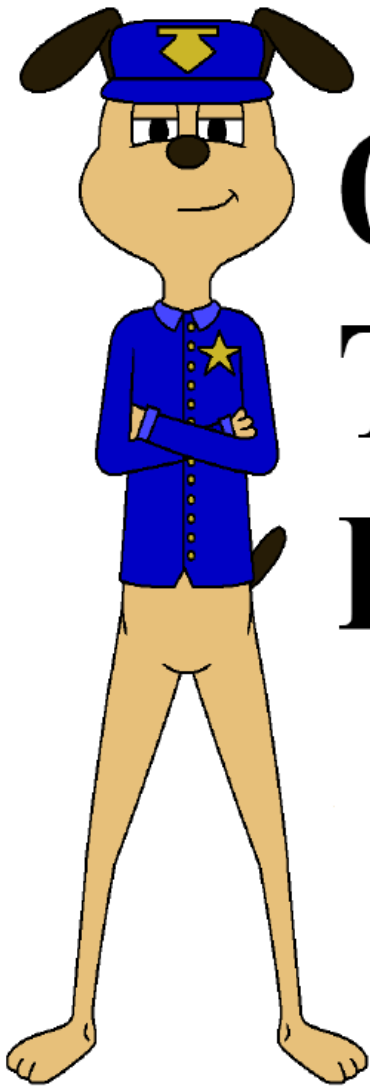

PLEASE REMEMBER TO CLEAN UP AFTER YOUR DOG. Any exhibitor caught not cleaning up after their dog will be subject to expulsion from further competition. Please... to **ensure our continued use of this site.**

No dogs are permitted in the washrooms.

Exhibitors may not dispose of water from buckets or tubs in the garbage cans.

Do **NOT** overfill the garbage bins, please let a club member know that they are full.

The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behaviour.

The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. Check for lost property at the club table.

UNSPORTSMANLIKE CONDUCT

11.1 It shall be deemed unsportsmanlike conduct if a person, during the running of or in connection with an event, abuses or harasses a judge, show official or any other person present in any capacity at the event.

Anyone found to be unkind, especially to minors, will be asked to leave the event - no refunds! Investigation will follow with possible further consequences. Be humble....be kind.

2. ENTER Online



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or interac for payment.

ALL Entries **MUST** be received by closing date: **WEDNESDAY, June 19th, 2024 @ 9:00pm Pacific Time**

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please **DO NOT** make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

BREEDER/OWNER/HANDLER COMPETITION (BOH - Sunday)

Unofficial/Exhibitor Eligibility

1. Exhibitors must declare their dog eligible for Breeder/Owner/Handler Competition at the time of entry using the check box on the entry form (either paper or electronic). If the handler changes from the time of entry to exhibition, the exhibitor is responsible for advising the ring steward if the entrant is no longer eligible.
2. The handler must be a breeder/owner of record listed in the catalogue.
3. Dogs must be handled by a listed breeder & handler throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
4. The BOH in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

Determining Best BOH in Breed

The selection of the Best BOH in Breed is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best BOH in Breed. Judging of the breed for the regular show may determine the dog that is awarded the Best BOH in Breed.

Guidelines:

- If the Best of Breed winner of the regular show is eligible for Best BOH in Breed it will also be awarded Best BOH in Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for Best BOH in Group.
- If the regular show Best of Breed winner is not eligible for Best BOH in Breed and the regular show Best of Opposite Sex is eligible, the regular show Best of Opposite Sex will compete against the eligible exhibits of the other sex to determine Best BOH in Breed.
- If neither the Best of Breed nor the Best of Opposite Sex from the regular show is eligible for the Best BOH in Breed and both the Select Dog and Select Bitch are eligible, the judge is to choose Best BOH in Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- If one of the Selects from the regular show is eligible for Best BOH in Breed, excuse all eligible champions and then choose Best BOH in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as the Best BOH in Breed.

If no dog remaining in the ring is eligible for the Best BOH in Breed competition, no award will be made and there will not be representation in group competition for the Best BOH in Group.

Group and Best in Show Competition

- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible breeder.
- Group judging for the Best BOH in Group may take place in separate rings from regular group judging.
- Judging for the Best BOH in Show is after regular Best in Show judging.

- 10+ years

For final judging the first place winner from each of the classes will be brought together for the final judging of Best in Veteran Sweepstakes.

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.
14. Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please **DO NOT** make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.
15. No person may approach a judge wither directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022



AGREEMENT

In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Victoria City Kennel Club, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
