LISTING FEES: \$9.66 (Cdn.) per dog not registered with The Canadian Kennel Club. Every Canadian dog must be individually registered. All foreign dogs, if not individually registered with CKC, must provide the foreign registration, pay the required listing fee and must apply for ERN number not later than 30 days after first entry in a trial.

Rule 14.7: "It shall be the duty and obligation of the test giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

Release and Indemnification of Landowners: By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the trial and agrees to release, save harmless and indemnify the owner(s) of any property upon which the trial is held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant, or his heirs, his executors and assigns.

NOTE **

24-12-3. CKC Non-member Participation Fee

a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee (\$57.60).

b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

c) The Premium List must carry a note stating that "This only applies to dogs wholly owned by Canadian resident non-members and is not applicable to CKC members or dogs co-owned with a CKC member."
