

DIRECTIONS TO THE FIELD: This is a large flat field with natural boundaries.

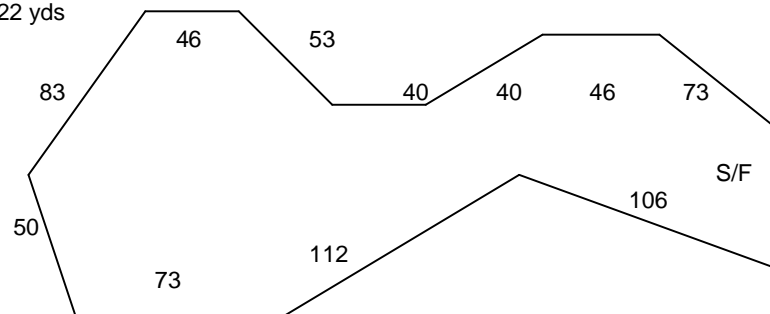
From Vancouver:

- Take the first right onto Fadden Rd, field is on the left.

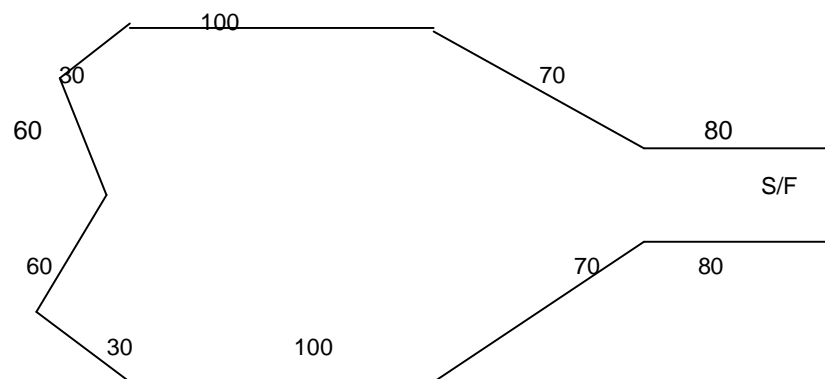

ELIGIBLE ENTRY:

For any Afghan Hound, Basenji, Borzoi, Greyhound, Ibizan Hound, Italian Greyhound, Irish Wolfhound, Pharaoh Hound, Saluki, Scottish Deerhound or Whippet that is one year of age or older on the date of the trial, and **certified** to run. All entrants must be registered, or eligible for registration, with the Canadian Kennel Club or have an ERN or PEN. Hounds with breed disqualifications, altered or neutered are eligible. Hounds currently disqualified under CKC, AKC or ASFA coursing rules are ineligible for the Open Stake, but are allowed to run in the Singles Stake.

STAKES:

Open all hounds, including Field Champions
Mixed for multiple breeds with entries of three or less, upon owners' agreement
Best in Field (Sun only) for all Best of Breed winners & 1st place Mixed Stake winner, for both days. Stake is offered only by decision on the day by the Field Trial Committee. At least two hounds must offer and sizes must be compatible.
Singles for any hound, at least 12 months old, not entered in the official trial. No championship points awarded. Run individually, once, on a full course. (LIMIT: 6 hounds)
Puppy Hounds, 6 to 18 months, not entered in the official trial of the day. No points are awarded. Run individually, once, on a shortened course

EQUIPMENT: Battery/ gas powered drag line lure machine with white plastic streamers.

PRIZES: Rosettes will be offered for all placements, inc Singles/ Puppies. Prizes will be awarded to BOB winners, 1st in Mixed Stake and Best in Field.

CHAMPIONSHIP POINTS: Will be awarded in the Open stake as follows:

1st place - four times number competing to a maximum of 40 points.
2nd place - three times number competing to a maximum of 30 points.
3rd place - two times number competing to a maximum of 20 points.
4th place - one times the number competing to a maximum of 10 points.
NBQ - no points awarded.

Assignments: Val /Tom - all breeds and stakes, both days.

Order of running: Reverse alphabetical both days. Best in Field (Sun only).

ADDITIONAL INFORMATION:

Entry forms not the same size and format as the official entry form will be rejected.

- Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.
- All competitors and spectators are requested NOT to bring a bitch in season onto the grounds. Please respect this request for the sake of all entered entire males. Please check your bitches before leaving home.
- Please present your dog for inspection **before** Roll Call when requested; bitches in season and lame hounds are not allowed to run in any stake.
- Bitches in season and lame hounds will have their entry refunded provided notice is given at or before Roll Call.
- Only the 1st place winner of the Mixed Stake may compete in Best in Field.
- Hounds not present at Roll Call will be scratched and entry fee not refunded.
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating this has happened.
- A \$5.00 fine will be levied against the owner of any hound loose on the field.
- For your comfort, please wear appropriate footwear.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the trial site.
- A valid rabies certificate is required to bring a dog into Canada.
- A port-a-potty will be available at the field.
- Please properly dispose of trash (e.g. cig. butts, dog poop), as this is an agricultural field.
- There will be a walking start. Do not release your dog before the 'T' in 'Tally-ho', else the dog may be assessed a penalty of between 1 and 10 points by each judge.

IMPORTANT NOTICE: (This does NOT apply to Singles entries.)

All hounds entering their first trial in Canada must be tested with another dog, not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form (included with this premium list) must be completed and submitted with the entry at the hound's first trial. Hounds with the following titles are exempt: ASFA F.Ch. or LCM; AKC F.Ch., S.C. or D.C., but are still required to submit the Hound Certification form with their name and exempting title(s) circled.

ATTENTION US EXHIBITORS: The Club will accept personal cheques, however, they must be payable in US funds for the full amount of the entry. Your cooperation is appreciated. US owned dogs may compete with an Event Registration Number (ERN). This number must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. An ERN can be obtained by submitting a copy of your AKC registration with a letter of request to the CKC offices. Fee is \$57.60 (request may be faxed using VISA). **A \$9.30 listing fee is payable for each dog not showing either a CKC/ERN registration number or a PEN number.**
