Test B - post entries accepted until 11:00 am

Limit of 40 dogs per test

WHAT IS THE CHASE ABILITY PROGRAM (CAP) TEST?

This exciting event, developed after the ever-popular Lure Coursing, allows dogs to uncover their natural prey drive through chasing a lure - all while having lots of fun. The Chase Ability Test also provides purebreds and mixed-breeds with the opportunity to compete and earn multiple titles and certificates in a field event that all dogs are capable of performing.

Two types of courses will be available: one for dogs shorter than 12 inches at the withers or brachycephalic dogs and another course for the remainder of the dogs entered. The Chase Ability program is a pass/fail event. How does your Dog earn a Pass? A dog must run alone, chasing the lure and complete the course with enthusiasm and without interruption.

ELIGIBILITY

Chase Ability Program participation is open to all purebred and mixed-breed dogs at least 12 months of age that are:

- individually registered with the CKC, or
- have an Event Registration Number (ERN), or
- have a Performance Event Number (PEN), or
- are eligible for registration with the CKC, or
- have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or
- have a Canine Companion Number (CCN) if it's a mixed breed.

The CAP is an athletic pursuit that requires your dog to be in very good condition. Your dog relies on you to ensure this. Females in season may not compete. If in the opinion of the Test Committee, any entry is found to be lame, unfit to compete or a female in season, it shall not be allowed to compete and the entry fees shall be refunded.

TITLES

There are three titles dogs may earn doing the Chase Ability Program. They are:

Chase Ability (CA)

awarded to a dog that passes the Chase Ability event three times under at least two different judges

Chase Ability Excellent (CAX)

awarded to a dog that passes the Chase Ability event a total of ten times (CA + 7 additional passes)

Chase Ability Excellent 2 (CAX 2)

awarded to a dog that passes the Chase Ability event a total of 20 times (CAX + 10). For every further 10 passes the dog may add a higher number after the CAX (CAX 3, CAX 4, etc.)

COURSE LENGTHS OFFERED:

300 yards: For dogs shorter than 12 inches at the withers and/or brachycephalic (flat-faced) dogs.

600 yards: For all dogs not eligible to run the short distance.

JUDGES:

Test A (morning): Barbara (Bobbi) Westman Edmonton AB

Test B (afternoon): Lynda Webster Edmonton AB

AWARDS:

A qualifying ribbon will be awarded to each dog that achieves a Pass grade.

A rosette will be awarded to each dog that achieves a CKC CAP title.

ATTENTION:

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

EQUIPMENT, FIELD CONDITIONS & ADDITIONAL INFORMATION:

The field is a mown sport field. A continuous loop system will be used for the Test. A drag system will be available for back-up.

- Dogs are requested to be present at Handlers Meeting. They are free to leave after completion of their run(s).
- Handlers' may use a slip lead when releasing their dogs. ALCA will have a limited number available for sale.
- Dogs are expected to be aroused and excited in the presence of the lure, but handlers' must be able to control their dogs for everyone's safety.
- Dogs may wear muzzles and/or catch collars at the owner/agent's discretion.
- Retractable (Flexi type) leads and/shock collars are not permitted.
- The Chair may excuse any hound from competition for any reason deemed justifiable.
- A \$10.00 fine, payable to ALCA, will be levied for any dog loose on the field at any time between Roll Call and the completion of the last test.
- A \$50.00 fine, payable to ALCA, will be levied for anyone who does not clean up after their dog.
- There is limited shade and no water available, so please come PREPARED.
- Portable toilets will be available.

DIRECTIONS TO THE FIELD:

This field is east of Sherwood Park. The tests will be held in the south-east side of the Uncas Elementary School yard.

From South: Hwy 21 north to Wye Road. Turn right (east) on Wye Road to Township Road 524 (approx. 14 km)

Turn left on Twp Rd 524 (signed for Uncas School).

Cross RR track, proceed. School is on right side, on the corner of Rge Rd 213 & Twp Rd 524 Turn right into School Parking Lot

From Central Edmonton: Sherwood Park Freeway east, becomes Wye Rd, continue to Hwy 21.

Cross Hwy 21 and follow directions as 'From South'

From North:

East on Hwy 16 to Rge Rd 213. South on Rge Rd 213 to Twp Rd 524.

Turn right at Twp Rd 524 & turn left at first driveway into school parking lot.

INSPECTION & HANDLERS' MEETING:

When you arrive at the venue, please check in with the Test Secretary with your dog/s.

Two members of the Test Committee will ask you to gait your dog away and back in accordance with the CKC CAP Rules that:

2.4.3 An inspection committee, consisting of two experienced persons, shall inspect each entry for lameness, fitness to compete and females in season.

2.4.4 If in the opinion of the committee, any entry is found to be lame, unfit to compete or a female is in season, it shall not be allowed to compete and the entry fees shall be refunded.

Handlers' Meeting will take place at 9:00 am for the A Test. Handlers' Meeting for the B Test will be approximately one hour after completion of the A Test.

ATTENTION CANADIAN EXHIBITORS – INFO REGARDING TITLES

The following is quoted from the CKC website:

“The following non-member participation fee now applies and is retroactive to January 1, 2011.

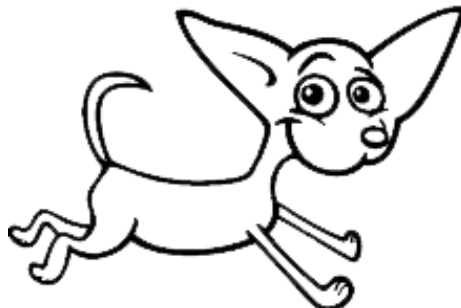
The non-member participation fee applies to all Canadian residents who participate in a CKC event but are not CKC members and a participating non-member can chose to purchase a CKC membership or pay the non-member fee. This only applies to dogs wholly owned by non- members and is not applicable to CKC members or dogs co-owned with a CKC member. In order for the CKC to efficiently manage recording and tracking points, it's important that non-members select one of the two options within 30 days of notification or, unfortunately, we will be forced to cancel any awards and titles

Non-Member Participation Fee

24-12-3. Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled.
- c) The Premium List must carry a note stating that “these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.”

Please include this signed document with your entry form if you are mailing your entries.

If you are entering on line, please bring signed Waiver to Roll Call.

I (we) agree that the Club holding this event has the right to refuse this entry for cause which the organizing committee shall deem to be sufficient.

I (we) hereby assume the sole responsibility for and agree to indemnify the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused or may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
