**Judges:** Allison Maxwell (Rounds 1 & 2 all levels) and Shauna Moore (Rounds 3 & 4 all levels)

**Fees:** \$20 single entry  
\$75 package (4 entries for the same dog)  
\$15 FEO (For Entertainment Only)  
\$ 25 Day/Gate entries and after pre-entry deadline, if space available

Entries open **February 12, 2018**

Pre-entry deadline: **March 20, 6:00 PM**

A valid entry includes the completed entry form and signed waiver with payment.

Female dogs in season may not compete.

This trial is open to reactive dogs EXCEPT those dogs that are currently deemed as dangerous, vicious or aggressive by any municipality, city or province. Please note that this does not include dogs that are deemed under breed specific legislation only and do not have a bite history.

Although the venue is indoors, runs may be limited to on leash for safety reasons.

Entries will be limited to 360 minutes of judging per judge. Gate entries will only be accepted if the trial has not filled.

Entries must be received by the pre-entry deadline to receive the reduced rate.

**Schedule:** For each level, rounds 1 & 2 will be run for all dogs, followed by rounds 3 & 4 at the same level. There will be 4 rings with only 2 rings used and only 1 dog running at any time.

**Class running order:** Classes will begin with all rounds of level 3, followed by level 4, Scent Private Investigator (SPI) and Scent Detective Diversion (SDD). Teams must have their level 4 title in order to enter the SPI and SDD classes. Teams may enter both of these classes.
