**GAME:** Dead ducks will be used in all stakes

**NOISE MAKERS:** The LOC reserves the rights to substitute devices that simulate the sound of a shot gun.

### NOTE:

The starting dog in the All-Age stakes will be determined by using the last two digits at the closing of the Toronto Stock Exchange (TSE) S&P/TSX composite index on Wednesday immediately preceding the trial.

Rotation: A system of rotation will be implemented for All-Age stakes after the first series (See CKC Rule Book section 6.6.1 c for details)

Judges may disqualify any dog which does not appear within 15 minutes of the time designated for its turn to be tried

Dogs will run in order unless excused by the marshal for that stake

Bitches and dogs will run in the order drawn. Bitches in season may not run.

Retriever Field Trial Rules & Regulations 6.6.1 (a) allow running out of order, if in the opinion of the Field Trial Committee such will result in a reasonable and desirable saving of time in the conduct of the trial. Committee members while engaged in any administration function are in this classification.

## CANADIAN KENNEL CLUB – Non-member participation fee

- a) An annual fee for awards and titles will be charged to a Canadian non-member of the CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled.

**Headquarters:**

On the 1<sup>st</sup> Concession Tiny 4 kms west of Simcoe County Road 6

GPS coordinates 44035'35.61"N 79o55'53.08"w

**Directions:**

**From the South and West:**

400 North to Barrie - Exit Bayfield St which becomes County Rd 27 - Proceed north through Elmvale then exit left on to County Rd 6- travel 2 Concessions then turn left. Watch for Tiny Marsh signs. Interpretive Centre is about 4 kms down on the right – watch for sign.

**From the East:**

Take Hwy 12 north to Coldwater. Exit on Vasey Rd (Left Turn, Flashing light) Continue through Waverley (lights) and Exit right onto County Rd 6. Travel 2 Concessions then turn left (watch for Tiny Marsh sign). The Interpretive Centre is about 4 kms down on the right (Watch for sign)

**From Midland Comfort Inn:**

From light on the corner ( King St) turn left onto HWY 12 and follow to County Rd 93. Turn left (south) to Waverley. Exit right onto County Rd 27 (west) to County Rd 6. Turn right and travel 2 Concessions then follow signs for Interpretive Centre down about 4 kms on the right. Watch for signs.
