ENTRY INFORMATION

1. Attention U.S. Exhibitors: A Personal cheque will be accepted, however, it must be payable in US funds and for the full entry amount. Personally discounted cheques will not be accepted. Do not mark cheque "payable in Canadian" or "funds at par". Your co-operation is appreciated.
2. If entering the same dog in conformation, obedience or exhibition only please use a separate entry form for each class.
3. An **INCOMPLETE ENTRY FORM WILL BE RETURNED**. Please ensure that your postal code is included. ALL NSF CHEQUES WILL BE CHARGED A \$30.00 SERVICE CHARGE.
4. Exhibitors must abide by the errors made when making the entry, regardless how or who made the entry.
5. An entry will not be accepted unless accompanied by the required fees. Post-dated cheques will not be accepted.
6. The Cobequid Dog Club reserves the right to reject any entry subject to CKC rules.
7. Only dogs, which are eligible for registration or are registered by the CKC, may be entered in these Show & Trials.
8. Overpayment of entry fees up to a maximum of \$5.00 will be considered a donation to CDC Trophy Fund.
9. The Exhibitor is responsible for knowing and complying with the Dog Show Rules of the CKC.
10. **There will be no prong or spike collars permitted at this venue.**
11. If because of; an act of God, riot, civil disturbance, extreme weather event, governmental orders, regulations, or decree, or other acts or circumstances beyond the control of the CDC, it is impossible to open or complete the Shows/Trials, no refund of entry fees will be made.

Temporary Competition Number (TCN) - * Effective March 2, 2020

A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN).

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number.

Dogs may still enter CKC events until without a registration number or ERN until March 2, 2020 by marking TCN on the entry form (or Listed if it is an older entry form). An email address is required on the entry form in this case. Before applying for a TCN online, exhibitors are encouraged to check their dog's profiles to determine

if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account.

* If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, there is no need to apply for a TCN. The CKC will update its records accordingly.

GENERAL INFORMATION

THE PRECINCTS OF THE SHOW WILL BE THE SHOW SITE. The show premises will be **opening at 7:00 am each day. The Show Judging will start at 8:00am** unless entries warrant an earlier start. Judging schedule and identification will be mailed/emailed as soon as possible after the entry closing date. The Cobequid Dog Club will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume liability in the event of an accident or other misfortune to dogs, exhibitors or patrons. Judging will not be delayed to accommodate an exhibitor or handler who fails to have his/her dog in the ring when required. The Show Superintendent will be in full charge of the trials. Exercise pens will be restricted at the discretion of the Show Superintendent. **Only dogs entered in the show are permitted within the show precincts please.** If because of; an act of God, riot, civil disturbance, extreme weather event, governmental orders, regulations, or decree, or other acts or circumstances beyond the control of the CDC, it is impossible to open or complete the Shows/Trials, no refund of entry fees will be made.

OFFICIAL JUNIOR HANDLING

There will be Junior Handling Saturday. Registration will be at the Show Secretary's table in the morning and must be done at **least one hour** in advance of the scheduled judging. Dogs competing in Junior Handling must be entered in one of the regular classes or in Exhibition Only. **A fee of \$2.00 for Junior Handling is required at time of registration. Advanced notice of entry would be appreciated.**

CONFORMATION CLASSES

Junior Puppy	A dog 6 months up to 9 months on the day of the show
Senior Puppy	A dog between 9 months and up to 12 months on the day of the show
12-18 Months	A dog between 12 months and up to 18 months on the day of the show
Canadian Bred	A dog which was born in Canada
Bred by Exhibitor	A dog owned and handled by the breeder
Open Class	A dog 6 months of age or older
Specials Only	Dogs who are Canadian Champions
Altered Class	For sexually altered dogs
Veteran Class	For dogs 7 years and older
Exhibition Only	For dogs 6 mo and older

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN).

To obtain an ERN number simply does the following:

1. Send a photocopy of the dog's registration certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN number.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.
4. Faxed requests will be accepted. Please indicate your Visa/MasterCard number expiry date, cardholders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN number within 30 days will result in cancellation of any wins, awards or scores. Please forward your request to:

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles.
