**NON-MEMBER PARTICIPATION FEE**

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number. In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

**Please Note:** These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.

**NO POST DATED CHEQUES ACCEPTED.** ALL NSF cheques are subject to a charge of **\$25.00**. N.S.F. cheques are considered **Non-Payment of entry fees** and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the shows/trials.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques "Payable In Canadian Funds", they will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.

**INCOMPLETE ENTRIES WILL BE RETURNED.** Agents and handlers please note that the **full name and address of owners MUST be filled in** and to whom ID's are to be returned. (Section 13.1.2 Dog Show Rules)

**CONFORMATION CLASSES**

- Baby Puppy A dog 3 months up to 6 months on the day of the show may be entered in non-pointing competition or may be entered "on exhibition only" for the "Exhibition Only" class see note below.
- Junior Puppy A dog 6 months up to 9 months on the day of the show.
- Senior Puppy A dog 9 months and up to 12 months on the day of the show.
- 12-18 Months A dog between 12 months and up to 18 months on the day of the show.
- Canadian Bred A which was born in Canada.
- Bred by Exhibitor A dog owned and handled by the breeder.
- Open Class A dog 6 months of age or older
- Specials Only Dogs who are Canadian Champions.
- Exhibition Only Dogs 6 months of age and over not in competition.
- NOTE** Dogs 3 months of age and under 6 months on the day of the show may be entered in Exhibition Only (not competing) providing that the owner of the puppies has also entered a dog in one of the Regular official classes. No exhibitor may enter more than 2 puppies.

**Champion & Championship Points ~ Chapter 1 Section 1 ~** A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of Championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded Best In Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. **NOTE: In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation of Championship Points.**

**MOVING UP TO SPECIALS ~ CONFORMATION**

A dog which is individually registered in the records of the CKC and has completed the requirements for a Championship in accordance with CKC Rules after the closing date and time for the show, may be transferred from one of the Regular classes to "Specials Only", providing the request is submitted to the Show Secretary IN WRITING and on the appropriate form at least ONE HOUR prior to the opening of the show, by the owner or handler.

### OBEDIENCE CLASSES

**Novice A & B, Open A & B, Utility A & B (Pre Novice, Novice C & Novice Intermediate)**

**SEPARATE ENTRIES ARE REQUIRED FOR EACH CLASS ENTERED ~ State Jump Height**

<b>Pre-Novice</b>	for all purebred dogs over 6 months of age (Not eligible for HIT Competition)
<b>“A” Classes</b>	for dogs handled by owner or immediate family member through all exercises
<b>“B” Classes</b>	for trainers, multiple entries, exhibitors who have attained a Cdn OTCH, degree or dogs who have earned titles in another country
<b>“C” Class</b>	for dogs who have completed a CD title in Canada (Not eligible for HIT Competition)
<b>Novice Intermediate</b>	(Not eligible for HIT Competition)
<b>Open “A” &amp; “B”</b>	for dogs who have earned a CD in Canada
<b>Utility “A” &amp; “B”</b>	for dogs who have earned a CDX in Canada
<b>Exhibition Only</b>	dogs 6 months and over, not in competition

### RALLY OBEDIENCE CLASSES

**Exhibitors entering both obedience and Rally must fill out separate entry forms**

Novice A	for dogs that have not earned the RN title or a CD or higher and is handled by the owner or immediate family
Novice B	for any dog until such time as a qualifying score in Advanced is earned
Advanced A	for dogs that have earned the RN title but not earned the RA title and is handled by the owner or immediate family member
Advanced B	for any dog that has earned the RN title
Excellent A	for dogs that have earned the RA title but not earned the RE title and is handled by the owner or immediate family member
Excellent B	for any dog that has earned the RA title

### MOVING UP IN OBEDIENCE AND RALLY OBEDIENCE

A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title, in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules may be moved up to the next level of Obedience or Rally Obedience competition providing the transfer was submitted to the Trial Secretary, in WRITING, by the owner or handler, one hour prior to the opening of the first trial. Where one or more trials are held on the same day in the same venue, the request for moving the dog up must be made a minimum of one hour prior to the scheduled start of the trial for which the dog is being moved up to, TRIAL SCHEDULE PERMITTING.

### BITCHES IN SEASON

**Bitches coming into season MAY NOT compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary receives a Veterinarian’s Certificate PRIOR to the commencement of the Trial.**

### EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN). To obtain an ERN simply do the following:

1. send a photocopy of the dog’s Registration Certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.

3. Ensure that you provide the CKC with your full return address to enable the ERN to be sent to you
4. Faxed requests will be accepted. Please indicate your VISA/MasterCard number and expiry date, the card holders name and signature.

This Event Registration Number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as “LISTED”, however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores. **SUPPORTED ENTRY FOR NEWFOUNDLAND DOGS SATURDAY 26TH OCT 2013 SHOW #2**

*The Island Dog Club will consider the judging of Newfoundland Dogs during Show #2 on Saturday the 26<sup>th</sup> October 2013 under judge Mr. Thomas Burke as a supported entry for the breed. In addition to the regular awards, rosettes and cash prizes will be offered and sponsored by Vicki and Dorman Leggo of Alegup Kennels for Best of Breed, Best of Opposite Sex, Best of Winners, Best Puppy In Breed, Winners Male, Winners Female, Reserve Winners Male, Reserve Winners Female and Best Baby Puppy In Breed. In addition to these prizes a prize will be awarded to the Highest Scoring Newfoundland Dog in the Obedience Trial #2 and Rally Obedience Trial Trial #2.*

**GENERAL INFORMATION**

Please ensure that you familiarize yourself with the following general information

1. The building will open 1 hour prior to the start of judging each day of the show (see judging schedule).
2. It is recommended that dogs be in the building at least 30 minutes prior to the judging of their breed. Judges are not required to wait for dogs and will adhere as closely as possible to the schedule. The owner and/or handler is responsible for having dogs at ringside when the breed is to be judged. Judging will commence each day at 8:00 a.m. unless entry dictates otherwise.
3. Exhibitors must abide by errors made when entering their dogs regardless of how or by whom the error(s) were made.
4. Only dogs eligible for CKC registration, ERN or PEN (Obedience) may enter these shows. The Show Committee reserves the right to refuse any entry subject to CKC rules.
5. The Show/Trial Superintendent will be in FULL Charge of the Shows & Trials.
6. Dogs not entered in either Shows or Trials will not be permitted within the building. The Show Superintendent is authorized to enforce this rule.
7. The Show Committee will use due care and diligence for the welfare of Dogs and Exhibitors but will not be responsible for, nor assume liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
8. Due to limited space X-PENS WILL BE LIMITED. Where possible please stack crates.
9. For set-up purposes the building will be open on Thursday 25<sup>th</sup> October 2012 from 4:00 p.m. to 8:00 p.m. (SHARP) as well as Friday until 8:00 p.m. (SHARP).
10. Incomplete entries will be returned. PLEASE NOTE: ensure that the complete name and address of the OWNER and that of the AGENT (if applicable) are correctly and completely filled in.

11. NO DOGS MAY BE LEFT IN THE BUILDING OVERNIGHT.
12. As per the Charlottetown Municipal By-Laws, you must CLEAN UP AFTER YOUR DOG. Failure to do so may result in you being fined.
13. As per PEI regulations NO SMOKING is allowed in public places. No smoking is allowed within 15 feet of the entry of a public building.
14. The precincts of the show shall be the designated area where the shows and trials are being held within the Charlottetown Canada Games and Trade Centre. Parking for exhibitors is to the side of the building at the Park Street Parking Lot. Upon unloading your vehicle it must be immediately moved to the side parking lot. DO NOT PARK IN THE FRONT PARKING LOT OR YOUR VEHICLE MAY BE TOWED AT YOUR OWN EXPENSE
15. OVERNIGHT CAMPERS AND RV PARKING IS FORBIDDEN ON CIVIC CENTRE PROPERTY.
