Entry limits: Handler/ Dog Teams may enter one, two, or all three components. A handler may enter one dog in each component, per level. Next day move-ups permitted: a dog may be entered in Started on both days and move-up to Advanced levels of the same components on Sunday, but will only be permitted to run the Advanced level if they pass Started.

Entry confirmations: Confirmations will be emailed upon receipt.

Entry method: **First come basis, online entry only.**

Fees: \$30 per Component entered

Payment: Payment must be received once your entry is confirmed. Accepted methods of payment are:

Onsite Entries: Check website after trial closing date for details and onsite entry form. Handlers must be present at check-in time with completed entry form and payment (cheque or cash).

Refunds: Refunds will be issued for any dog withdrawing for medical reasons. A Veterinarian Certificate must be submitted before the start of the trial.

Awards: Qualifying ribbons will be presented per component, and rosettes for titles & placements.

Titles: All three (3) components (Container, Interior, Exterior) must be successfully completed (qualifying scores earned) to earn the SD-S (or SD-A) title. The SP (Special) designation will be added to the title of any dog that completes the three components on the same day, at the same trial.

Participant Information:

TRAINING AND/ OR UNOFFICIAL USE OF ODOUR IS NOT PERMITTED ON TRIAL GROUNDS.

DOGS: Dogs must be under control at all times. Pick up after your dog(s) immediately. Dogs **MUST** be on leash when not crated or in the search areas. Do not approach other dogs without explicit permission. Do not allow your dog to approach other dogs or people without explicit permission.

Running Order: Running order will be decided by random draw. Order will be posted at check-in on trial day.

Bitches in heat: Bitches in heat are allowed to compete, and will run last in each component level. We ask that you notify us ASAP if your bitch is in heat so we can adjust the running order.

Food & Refreshments: Many restaurants within 5 minutes from site. (The Keg, Tony Roma's, Tim Horton's, Subway, etc.)

Crating: Crating will be in your vehicle. Please bring appropriate equipment to keep your dog(s) comfortable.
