- 2. No refund of entry fees will be made if it is impossible to open or complete the trials because of riot, civil disturbance, or other acts beyond the control of the COKC.
- 3. COKC will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume any liability in the event of accident or other mishap caused to either dogs, exhibitors or spectators whether the results of accident or otherwise. A dog should not be touched without the permission of the owner or handler.
- 4. By City Ordinance the COKC building is a **NON-SMOKING** BUILDING. This rule will be strictly enforced.

THERE WILL BE NO PROVISION FOR COVER IN CASE OF INCLEMENT WEATHER.

#### **ON-SITE CANTEEN**
