POTENTIAL ADDITIONAL FEES:

CKC now requires a non member participation fee of \$57.60 plus HST for any titles earned. These fees apply only to CANADIAN dogs <u>wholly owned by non-CKC members</u> and are <u>not</u> applicable to CKC members. CKC membership forms are available at <u>http://www.ckc.ca/en/Default.aspx?tabid=438</u> See page 8 for more info on this topic.. Pre entries Close– April 3^{rd} 2013. Please do not send an entry that requires our trial secretary to travel to the post office to sign for receipt.

A LISTING FEE must accompany the entry when a dog is eligible for, but does not possess a CKC individual Registration number or an Event Registration Number (ERN) or Performance Event Number (PEN) or for Foreign born Miniature Dachshunds under one year of age. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Agility Rules and Regulations. At the option of the handler, a dog may wear either a well-fitting plain buckle collar, a quick-release collar, or no collar. Fancy collars, choke collars, pinch collars, or other training collars are prohibited. Collars which are too tight or so large that they hang down unreasonable in front of the dog are not permitted. There shall be nothing hanging from the collar Food and toys are not permitted in the course area and handlers are not permitted to use whistles or other training devices in the ring or within 10 feet of the course.

Entry Requirements:

Every dog entered in a CKC approved Agility Trial must be purebred and must be registered with the CKC, or have an **Event Registration** #, a **Performance Event Number** #,

Miscellaneous Certification # or be eligible for Registration with the CKC, or have a CKC miscellaneous Class Certification Number.

The dog must be at least 18 months of age, may be spayed or neutered. The dog may not be lame or compete if it has tape or bandages.

A dog can only be entered once in any one class at a trial.

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events do NOT require a CKC registration number but will require an Event Registration Number (ERN).

Cheques or Money order payment only. Sorry, WCOBC can **NOT** accept credit card or online entries.

CLASSES

There are 3 divisions, Regular and Selected, and Veteran.

Each of these has a Standard Class and Jumpers with Weaves (JWW) at the following levels: Regular - Novice A and B, Intermediate, Excellent A and B. Selected and veteran - Novice. Intermediate, Excellent A and B

Selected division information:

The selected division will run the same course regular but will jump one height lower and receive e 10% more time added.

The owner may choose to enter the Selected division in lieu of entering the Regular division at any trial. The dog **must be entered only in Selected Class or Regular Classes at the same set of trials**. (a dog may move back and forth between the Selected Classes and the Regular Classes, but not at the same set of trials offered by a club on the same day or on consecutive days.)

NOTE: Selected Novice division does not have A and B

Some items to note!

WCOBC regrets to inform all Non Members of CKC that there is a new initiative taken by CKC and announced on January 13, 2011 which requires all non members to pay a fee or remit their membership to CKC if they intend to have their dog's titles documented.

Our WCOBC trial committee's understanding of this is as follows. It should be made very clear that this applies only to dogs wholly owned by Canadians who are not CKC members. CKC is working on developing a form but was not available when this premium was published. Individuals have 2 choices. 1. waiting for a letter from CKC Head Office notifying them. 2. calling ahead to CKC's Client Services Department and paying the \$57.00.

We understand that this Non-Member Participation Fee is to be applied to titles. So, if a dog earns a qualifying score that's fine, it is when the title is issued that CKC will contact the owner. However, if the fee is not paid OR the individual chooses not to become a CKC member, all of the qualifying scores earned after January 1, 2011 will be cancelled with the title.

The following is quoted from the CKC website

"The following non-member participation fee now applies and is retroactive to January 1,2011. The non-member participation fee applies to all Canadian residents who participate in a CKC event but are not CKC members and a participating non-member can chose to purchase a CKC membership or pay the non-member fee. This only applies to dogs wholly owned by non members and is not applicable to CKC members or dogs co-owned with a CKC member. In order for the CKC to efficiently manage recording and tracking points, it's important that non-members select one of the two options within 30 days of notification or, unfortunately, we will be forced to cancel any awards and titles

Non-Member Participation Fee

24-12-3. Non-member participation fee

a)An annual non-member participation fee for awards and titles will be charged to a Canadian nonmember of CKC. The fee will match the ERN fee.

b)In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled.

c)The Premium List must carry a note stating that " these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

ALSO Note New Breeds Eligible to Compete in 2011

Effective January 1, 2011 the Lancashire Heeler is eligible to participate in CKC events and has been assigned to Group 7 (Herding).

Effective July 1, 2011 the Dogue de Bordeaux will be eligible to participate in CKC events and has been assigned to Group 3 (Working).

At the option of the handler, a dog 7 years or older may be entered in the Veterans division. The dog cannot revert back to Regular or Selected divisions. The dog will retain titles and qualifying scores towards titles accumulated. All veterans will complete as if running n the selected division at one or two jump heights lower than regular with 10% additional time as allocated in the Selected division.

Agility Novice A: For persons and dogs that have never acquired an agility title in any country or organization.

Agility Novice B: For agility instructors and judges, and for dogs that have acquired the Agility Novice Title, but have not earned a qualifying score in Agility Intermediate; and for persons who have previously exhibited a dog to an agility title in any agility organization.

Agility Intermediate: Is open to dogs that have acquired the Agility Novice title, and to those dogs which have acquired the Agility Intermediate title but have not yet acquired a qualifying score towards the Agility Excellent Title.

Agility Excellent A: For dogs that have acquired the Agility Intermediate title, but have not yet earned the Agility Excellent title.

Agility Excellent B: For dogs that have acquired the Agility Excellent title or the Agility Master Excellent title.

Events Offered

Standard agility and Jumpers with weaves –

Equipment and course familiarization:

- Upon previous arrangement, There will be equipment familiarization on Saturday morning for Novice dogs only and on Sunday morning for Novice dogs entered in trials 3 and 4 only.
- A warm up area with a single practice jump will be provided for dogs entered in the trials.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class

Moving Up: A dog that has received 3 qualifying scores from at least 2 different judges, may be transferred to the next level provided that request is received at least <u>one hour prior</u> to the commencement of the trial.

List of Awards and Prizes:

- Ribbons will be provided for $1^{st} 4^{th}$ in each class and jump height.

A Qualifying score is 85 points or more out of a possible 100 points, with no nonqualifying deductions except Excellent B where a perfect run is required.

The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

Foreign Exhibitors

Entry Payment: Please note that fees are due and payable in Canadian dollars.
