No entry shall be accepted from a dog or handle disqualified from the ASCA Conformation program, a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA.

You must have an ASCA Tracking number ("this is a number with which ASCA tracks your competition legs earned") to run your dogs. You may get the form and information to obtain that number from the ASCA Website. http://www.asca.org/Portals/0/trackapp.pdf

#### **Directions to Tucker Creek Farm:**

*From Thunder Bay*: head south on Highway 61 towards the US border. We are 6.5 miles / 10.5 km past the airport, 1 km past the Neebing Roadhouse. We are the first driveway on the right hand side just past ReCool Recycling and across from DeBruins Nursery.

From the US border, heading north on Highway 61 we are approximately 28 miles / 46 km from the border towards the city of Thunder Bay. The address is 3020 Highway 61, on the left, opposite DeBruins Nursery. If you see the "Welcome to Thunder Bay" sign you have just passed our driveway. ©

Please pull off the sides of the driveway. Please pick up after your dogs and put the bags in the garbage cans provided. There will be either a luncheon or concession for the trials. BBQ, snacks and refreshments will be available for sale.
