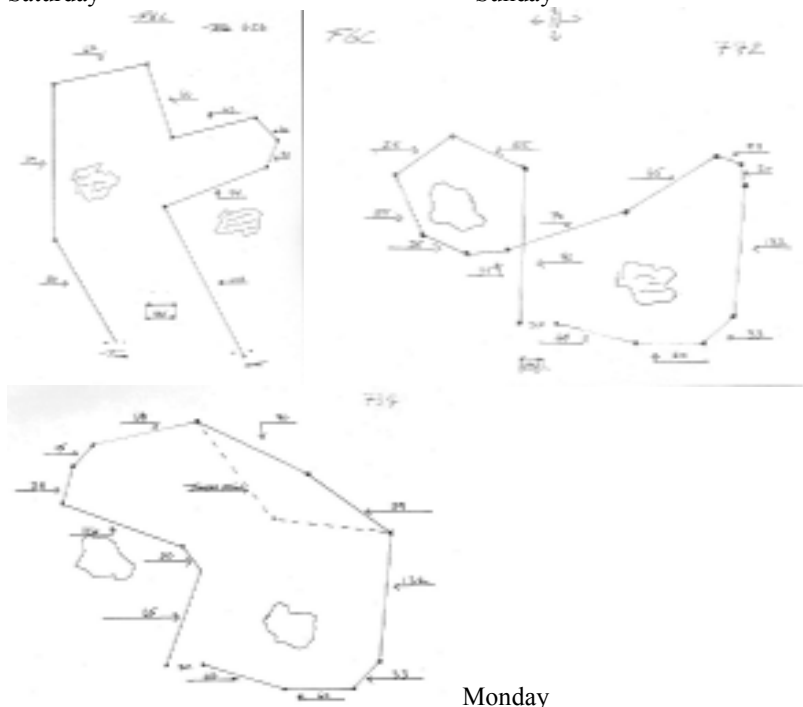


Not to scale. Field is a slightly rolling pasture land with rough footing.

- ☞ Overnight parking permitted on field. Units must be self-contained.
- ☞ Visit these websites for dog friendly accommodations in South Calgary or Strathmore www.doginmysuitcase.com, www.travelpets.com, www.officialpethotels.com. Book early, do not leave your dog unattended and remember to "Stoop& Scoop".
- ☞ Stakes will be split if the entry is 24 or more hounds at roll call.
- ☞ Hounds will be run twice, in braces or trios (except single dog entries) unless dismissed, excused or declared ineligible.
- ☞ Lame hounds or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.
- ☞ Hounds not present at roll call shall be scratched with no refunds. **No Exceptions.**
- ☞ All handlers must use a slip lead when releasing a hound. A **Standing Start** will be used on Tally-Ho.
- ☞ Leg wrappings must be of a neutral colour to comply with CKC rules. Muzzles & catch collars may be used at the handler's discretion
- ☞ A \$5.00 fine will be assessed for loose dogs on the field after roll call and until after Best in Field.
- ☞ Bring your own water and shade.
- ☞ No catalogue will be published. Score sheets will be available.
- ☞ A veterinary clinic is within easy access to the field.
- ☞ **Please clean up after yourselves and your dogs. Do not stuff plastic bags down holes. Please use the trash receptacles provided.**

Eligible Entries

Open to any Afghan, Basenji, Borzoi, Greyhound, Ibizan, Italian Greyhound, Pharaoh Hound, Saluki, Scottish Deerhound, Whippet, Irish Wolfhound or CKC Miscellaneous Sighthound that is one year or older the day of the trial. All entrants must be registered or eligible for registration, with the Canadian Kennel Club, have ERN # or PEN #. Hounds presently disqualified or declared ineligible under CKC, ASFA, CSFA OR AKC rules cannot compete. Hounds with breed standard disqualifications, or altered/neutered are eligible to enter the lure field trial. **Hounds must pre-qualify prior to entering their first trial in Canada. See enclosed form.**

From the North: New Directions ←

QE Hwy #2 South To Stoney Trail Exit 271. Take Eastbound Stoney Trail to Hwy #22X East Exit 96. Take Hwy 22X East to Rge Rd 282 (Country Club Pet Resort). Turn Right and go to Twp Rd 224. Right on Twp Rd 224 and the field entrance will be on your right about .25 mi from the corner. Follow signs.

From the South: New Directions ←

QE Hwy #2 North to Stoney Trail Exit 234A. Exit East (right) on Stoney Trail to Hwy #22X East Exit 96. Take Hwy #22X Exit East and follow directions from North.

From the West:: New Directions ←

Trans Canada Hwy (#1) to Stoney Trail (Hwy #201). Go East on Stoney Trail to Hwy #22X East Exit 96. Take Hwy #22X Exit East and follow directions from North.

SINGLES COMPETITION

Rolling Roll Call from when you arrive until 9:00 AM All Three Days. Your dog is

declared ineligible or not ready for running in competition, but you would like your dog judged? This is the place to be! Dogs will be run individually and scored by both judges. Hounds will run after the open stake has completed its preliminary round and then again after the open stake has completed its final round. **Your dog will be only given ONE opportunities to chase the lure each time it comes to the line. Handlers will not be able to run/walk the course with their hounds.** A random draw will determine the order of running of dogs in this stake. Dogs must wear a blanket. No points are awarded and all ties are settled by a coin toss. A trophy and ribbon will be awarded to 1st place and ribbons for 2nd to NBQ.

Take a Walk with the Judges

As part of their judging assignment, our judges must walk the course to ensure that a safe course plan has been laid out for *your* hounds. On this field that means looking for and filling holes. You and a shovel are encouraged to join them in assuring the safety of *your* hounds.

Placements and Awards

Chapter 7, Section 1: Championship points are awarded in regular stakes only on the following basis:

- 1st: 4 x # of hounds competing in stake, to a max. of 40 points
- 2nd: 3 x # of hounds competing in stake, to a max. of 30 points
- 3rd: 2 x # of hounds competing in stake, to a max. of 20 points
- 4th: 1 x # of hounds competing in stake, to a max. of 10 points
- NBQ: No points

No hound shall receive a placement or points if it does not score at least 50% of the total possible combined scores. If a hound has been **excused** in the preliminary run, that hound shall not count as having been in competition.

All prizes must be claimed at the trial. They will NOT be mailed.

First Time Entered Hounds:

Effective July 1 1998, hounds entering their first trial in Canada must be tested with another hound, preferably not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification Form (included with this premium list) must be completed and **submitted with the entry at the hound's first trial**. Hounds with the following titles are exempt: ASFA F.Ch or LCM, AKC F. Ch., S.C. or D.C., but are still required to submit the Hound Certification Form with their name and exempt titles circled.

ATTENTION ALL FOREIGN EXHIBITORS

Effective January 1, 1992 all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an **Event Registration Number (ERN)**. This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. ERN MUST BE APPLIED FOR WITHIN 30 DAYS OF FIRST DAY OF ENTERING A CKC EVENT TO AVOID CANCELLATION OF AWARDS. Visit www.ckc.ca for the most up-to date fees for the ERN.

Non Member Participation Fee

The following non-member participation fee now applies. The non-member participation fee applies to all Canadian residents who participate in a CKC event but are not CKC members and a participating non-member can chose to purchase a CKC membership or pay the non-member fee. This only applies to dogs wholly owned by non members and is not applicable to CKC members or dogs co-owned with a CKC member. In order for the CKC to efficiently manage recording and tracking points, it's important that non-members select one of the two options within 30 days of notification or, unfortunately, CKC will be forced to cancel any awards and titles

24-12-3. Non-member participation fee

- An **annual** non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- The Premium List must carry a note stating that “these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.”
