**REMINDERS TO EXHIBITORS**

**Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC rules and regulations, including but not limited to the following:**

- This event is open to all dogs being at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance, or any dogs showing signs of aggression.
- Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC.
- No leads, collars, food, toys or other aids or devices shall be permitted on the course at any time, including during familiarization and course-walking. It is expressly understood that exhibitors alone are responsible for the behaviour of their dogs and/or children.
- All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behaviour upon exit of the ring may be disqualified and / or required to leave the show grounds and NO REFUND of fees shall be given.
- Exhibitors must keep crating and exercise areas clean. Please pick up after yourself and your dogs. We need to keep this great new venue available to us and other dog clubs!
- Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behaviour may be asked to leave the show grounds and no refund of fees paid will be made.
- If an exhibitor must be asked to leave the show grounds for any reason, they will not be issued a refund.
- There will be no refund after the closing date for dogs that are withdrawn, with the exception of bitches in season or sick/ injured dogs if we are provided with a vet's certificate.
