**2024 National Retriever Championship Qualification Requirements**: Entry in the National Retriever Championship Stake shall be limited to the winner(s) and finalists of the 2023 National Retriever Championship stake, the winners of the 2023 US National and 2024 US National Amateur Retriever Championship Stakes, and those dogs that have placed 1st, 2nd, 3rd or 4th in an Open, Special, Limited, Amateur or Owner Handler Amateur All Age Stake approved by the Canadian Kennel Club in which championship points were awarded and hosted by a Class A National Retriever Club of Canada Member club, this current year (2024) and the previous calendar year (2023).

- For dogs without a permanent CKC or ERN registration number, a Temporary Competition Number (TCN) must be applied for (online, paper application, or contact Show & Trials Division CKC 1-855-364-7252), BEFORE SUBMITTING AN ENTRY FEE FOR AN EVENT.
- Entry Forms must be completed in full and accompanied by ENTRY FEES AND, if applicable, \$11.30 Temporary Competition Fee.
- Please Note CKC Ruling: Canadian Resident non CKC Members running a wholly owned dog cannot win a
  placement towards awards unless they pay a non-member participation fee or a membership fee to the CKC.
  CKC Registration or ERN must be applied for within 30 days of the trial, or all awards will be cancelled.

Scratch Fee Policy: Bitches in season may not compete and must be withdrawn. All entry fees paid for bitches in season will be returned, provided a notice in writing is given to the Field Trial Secretary. Entry fees paid for dogs withdrawn because of an injury, illness or death, shall be refunded in full. Prior to such refund the Host Club may require an appropriate veterinary certificate to be given to the Field Trial Secretary.

The vetting must take place within the 24-hour period preceding the stake and must be done by the official veterinarian. Spayed females will be exempt from vetting if a veterinary certificate of spaying accompanies the entry form.

Starting Time: Sunday, Sept.15<sup>th</sup> – Caravan 7:00am, opening ceremonies 7:30 am.

Starting Location: To be announced and location will be marked.

Game Birds: Ducks and/or pheasants will be used in all tests.

#### **Titles Awarded**

National Field Trial Champion NFTCH - The National Field Trial Champion title, NFTCH, is awarded to the winner of the National Retriever Championship stake.

National Amateur Field Trial Champion NAFTCH - The National Amateur Field Trial Champion title, NAFTCH, is awarded to the top Amateur handled dog when the winner is handled by a Professional and the top Amateur handled dog completes the  $10^{th}$  series of the National Retriever Championship stake. National Finalists are the dogs who complete the  $10^{th}$  series without an eliminating fault.

#### CKC Rules:

**CKC Rule 14.4.1** The winner of the National Retriever Championship Stake shall become a Field Trial Champion of Record and shall be entitled to be designated the National Field Trial Champion of "year".

**CKC Rule 14.5.1** When the winner of the National Retriever Championship is handled by a Professional, the National Amateur Field Trial Champion title, NAFTCH, is awarded to the top Amateur handled dog who has completed the 10th series of the National Retriever Championship stake shall become an Amateur Field Trial Champion of Record and shall be entitled to be designated the National Amateur Field Trial Champion of "year".

**Photos:** Participants agree that their image, and that of their dog may be used by any official sponsor of the National Retriever Club of Canada to promote the sponsor's business endeavours in perpetuity and without further compensation.

**CKC Rule 21.7:** It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Release and Indemnification of Landowners and The National Retriever Club of Canada and North Bay & District Retriever Training Club: By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all their heirs, executors, and assigns.

#### On the Grounds Behaviour and Conduct

- 1. In the National Retriever Championship Stake, the Guidelines For Ethical Training at Nationals has been adopted. As much training may be done as required BEFORE entering the trial grounds or AFTER running a test. NO TRAINING may be done after observing a test until you have run. After a series has been officially set up by the judges, during the running of the stake, no competing dog shall, while on the grounds, be exercised, trained, or worked except for a bumper thrown by the handler and this only in an especially approved area and only for the purpose of exercising the dog.
- 2. Any dog not entered in the stake and interfering with the running of the stake may be required to be removed.
- 3. Exercise areas to be clearly defined.
- 4. Rules on the failure to appear on line when called to be strictly enforced. It is a practise of some competitors to be late when they are No. 1 or 2.
- 5. No dog to be allowed to watch any test having just run the test or not, thus eliminating confusion as to who has run and who has not and reducing the chance of dog fights.
- 6. Rotation number will be 1/5 (20%) of the number of dogs that will run the next test. If the calculation does not result in a whole number round up to the nearest whole number ie. if the calculation results in 10.2 round up to 11. Use the rotation number to count the number of running dogs after the previous starting dog to identify the next starting dog. (In the example below the next starting dog would be the 11th running dog after the previous starting dog.) There shall be a minimum rotation of 3 dogs. No dog should be the starting dog more than once. (If the rotation identifies a dog that has already started once, select the next running dog that has not yet started.)

#### Example:

If 51 dogs are called back to the next test, the rotation number will be 51 X 0.2 = 10.2 which is rounded up to 11. The starting dog of the previous test was #33. Dog numbers 25, 27, 33, 34, 42, 44, 45 and 51 were not called back. All other dogs between 25 and 55 were called back, therefore, dogs 26, 28, 29, 30, 31, 32, 35, 36, 37, 38, 39, 40, 41, 43, 46, 47, 48, 49, 50, 52, 53, 54 and 55 will run the next test along with 28 others. #48 will be the starting dog for the next test as it is the 11th running dog after #33 the previous starter.

- 7. The first scheduled test of the National will be announced. Each next scheduled test will be posted with callbacks. The procedure will help create fairness for all by eliminating possible competitive advantage for those involved in putting on the trial. Judges have no obligation to go ahead with a scheduled test as conditions may change.
- 8. White clothing is not allowed in the gallery or behind the line.
- 9. Please note that to qualify to run the National, the host club where you received your placing must be a paid-up member of the NRCC in good standing.
