## ENTRY INFORMATION:

**Early Bird Entry is \$20.00 per run. Regular Entry is \$22.00 per run.** Entries for the **Early Bird Discount** MUST be received by **Friday March 13, 2015**. Full price entries MUST be received by **Friday April 3, 2015**.

TEAM EVENTS are \$10.00 per dog for early bird entry and \$11.00 per dog for regular entry. Please indicate whether you have a partner and who that partner is. If this information is not included you will be paired at the discretion of the Trial Committee.

FEO (for exhibition only) is \$11.00 per run (indicate FEO clearly - no early bird discount).

CARO TRIAL CLASSES: Novice A&B & BRACE, Advanced A&B&C & BRACE, Excellent B&C, Versatility B&C, Versatility Excellent, Novice Team, Advanced Team, Excellent Team.

CARO Dog ID Cards: Dogs must be at least six months of age and must be registered with CARO to compete. Forms are available at <http://www.canadianrallyo.ca>. You may submit your registration directly to CARO or include your registration form and fee with your CARO trial entry.

CARO RULES: For a complete description of the Rally Obedience rules, explanations, exercises, class details (Novice A or B, C Stream etc) go to [www.canadianrallyo.ca](http://www.canadianrallyo.ca)

MOVE-UPS: Permitted at any time of day as time permits.

AWARDS: Blue qualifying ribbons will be awarded to each team achieving a score of 170 or better. Titling ribbons will be awarded. Please let us know if you may be eligible for "special title" ribbons.

DOG JUMP HEIGHTS: Please include your dog's jump height even if you are in a class with no jumping required. Heights are measured from withers (highest part of shoulders) to the ground.

<u>Shoulder Height</u>	<u>Jump Height</u>
Under 12 inches	4 inches
12 inches to under 16 inches	8 inches
16 inches to under 20 inches	12 inches
20 inches and over	14 inches

## Judging Schedule

Note: Name on entry form indicates who is judging the event. There will be two rings alternating starting with event 1. Confirmations and judging schedule will be emailed after closing date.

Dogs may compete in more than one level at the same trial, under the following provision. The final qualifying run for the first title must occur in the same trial as the legs for the next title. For example: A team is competing in Trial T06-0000. They have two qualifying legs on their Novice title. They sign up for 4 runs. They do Run #1 (Novice) and fail. They pass Run #2 (Advanced) and Run #3 (Advanced). Run #4 is another Novice run, and they are entered in it, too.

1. If the dog passes Run #4 (Novice), this will complete his Novice title, and his 2 Advanced legs will count toward his Advanced title.
2. If the dog fails Run#4, and does not earn his Novice title, then the Advanced legs will not count toward his Advanced title. They will become For Exhibition Only. The final Novice qualifying run must occur in the same trial as the two Advanced runs for those two runs to count. The same rules apply for teams trying for Advanced/Excellent and Excellent/Versatility titles.

You may enter any class FEO if desired.

**GENERAL INFORMATION:** Trial is in an unheated barn with packed sand footing. There will be **patio heaters and a warming room** (plus a heated bathroom) available. Dress in layers. **There is no concession on site however there will be crockpots of soup & chili and a bun and cookies for \$4. Also there will be coffee and hot water for hot chocolate and tea.** Stores & restaurants are a 5 minute drive. Parking for large recreation vehicles is NOT available.

**OVERNIGHT ACCOMMODATION:** Possible hotels include Best Western Villager (park is directly behind) or Village Green Hotel (grassed walking area). It is not possible to camp overnight on site. A nearby camp site is Swan Lake RV Park & Campground at 7235 Old Kamloops Road.

**BARN ETIQUETTE:** As this is a working barn and horses & farm dogs are about, **DOGS MUST BE ON LEASH AT ALL TIMES.** **Please do not walk dogs in horse stall area or DOWN THE DRIVEWAY.** On leash around the parking lot is ok. Please pick up after your dogs. If they eliminate on or close to the manure pile leave the deposit. **DOGS MUST BE CRATED** when not competing or preparing to compete. **There is NO SMOKING anywhere on the grounds. Only smoke in your car.**

**SPECTATORS:** Spectators are welcome but please leave non-competing dogs at home.

**GENERAL AGREEMENT/DISCLAIMER**

The person who signs this agreement represents that he/she (“I”) is authorized to enter into this agreement. I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner of the dog entered hereon. In consideration of the acceptance of this entry, I/we (“I”) have read, and understand and will abide by the Official Rules and Regulations of the Canadian Association of Rally Obedience (CARO) in the effect at the time of this entry, and by any additional rules and regulations set out by “Stables at Hidden Hills” or Dog’O’Pogo Agility Club.
