**Attention U.S. Exhibitors:** We will accept US checks as noted in entry fees. Due to the constantly fluctuating currency rates, discounted checks will not be accepted. Personal checks will be accepted; however, they must be made payable in US funds in amounts noted under entry fees.

**Eligibility:** To be eligible to compete in this trial, a dog must be at least 6 months of age and registered with the CKC or eligible for registration with the CKC, have a PEN, an ERN or have a CKC MCN (Miscellaneous Certificate Number) or a CCN (Canine Companion Number). Bitches in season are not permitted to compete in the trial however, entry and listing fees will be returned, providing a veterinarian's certificate stating that the bitch was in season within the 10 day period preceding the trial is submitted to the Trial Secretary on or before the day of the trial.

*With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will replace the current system of entering events with "listed dogs" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).*

*A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN.*

*While there is no fee to obtain a TCN, exhibitors will still be required to pay TCN Fees (formerly called listing fees) when entering events using this number.*

### **Non-Members Participation Fee**

Effective January 1, 2011, the CKC instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. **Move-ups:** Move-ups are permitted between trials. The transfer must be submitted to the trial secretary on the official Move-up form, 30 minutes before the Trial begins.

**Ribbons Obedience:** Rosettes will be offered for all places 1st to 4th in each class as well as flats for all qualifying scores.

Obedience High In Trial will receive a Large Rosette and Prize

**Ribbons Rally:** Rosettes will be offered for all places 1st to 4th in each class as well as flats for all qualifying scores.

**Rosettes will also be offered for any new title earned at this trial.**

**Food:** Food is available on site and nearby.

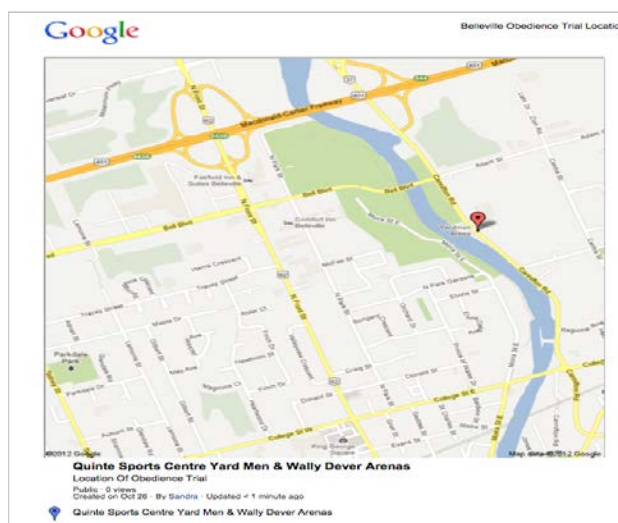
