GENERAL INFORMATION

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".

Eligibility to Compete - To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed. *See below for TCN numbers. A dog may be spayed, neutered or debarked. Dogs must not be lame or must not compete if tape or bandages may impair its working ability. Dogs with physical challenges are eligible to compete, in the opinion of the judge; they display no signs of physical discomfort and can safely complete the search.

Bitches in season - Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Scent Detection Levels offered – Instinct and Novice, Open, Excellent and Master (Containers, Interior and Exterior). Both days, limited class entries. Exhibitors CANNOT compete in the same component with multiple dogs. ALL levels will be limited. No move ups will be permitted between components. Move ups will be permitted before the commencement of the these trials, with NEW paperwork.

Scent Detection Prize List - Flat ribbons will be given for all qualifying scores. Rosettes for titles will be available, the day of the trial or shortly thereafter, depending on number of titles earned.

Penalties issued by club - Dropping food while rewarding is considered a contamination. Contamination of the search area will result in a non-qualifying score and any dog who urinates, defecates or vomits within the search area will be excused from the competition and a monetary penalty may be enforced in either situation. Destruction of trial property (excessive scratching or subsequent breaking of an item) will have a monetary penalty of \$10.00 enforced.

Tendering of a dishonoured cheque for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards

CKC Non-Member Participation Fee / Non-member participation fee /TCN #'s

The new process requires all owners of unregistered, recognized breeds entering events to obtain a <u>Temporary Competition</u> <u>Number</u> (TCN). TCNs will replace the current system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

TCNs will be required to enter all events with closing dates after March 2, 2020.
