To keep the event running smoothly, all competitors will be expected to keep track of the running order and to be in the 'on deck' area prior to your run.

ALL DOGS COMPETING <u>MUST</u> BE REGISTERED WITH CARO TO COMPETE. REGISTRATION FORMS ARE AVAILABLE AT http://www.canadianrallyo.ca AND MUST BE SUBMITTED TO CARO BEFORE THE TRIAL OR ACCOMPANY YOUR ENTRY.

REGISTERING YOUR DOG WITH CARO IS YOUR RESPONSIBILITY. UNLESS YOU ARE SUBMITTING YOUR DOGN REGISTRATION WITH YOUR ENTRY, YOU MUST SHOW YOUR DOG'S REGISTRATION CARD AT THE TRIAL.

FACILITIES

This is an indoor facility in Brandon. Limited space for crating indoors is available and there are washrooms and water onsite. Bring your own lunch or take advantage of numerous restaurants/grocery stores within a 10 minute drive.

All dogs must be crated, in an ex-pen, or on leash when not in the ring. Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. We ask that all dogs be exercised in out enclosed area to the back of the building or across the road in the off leash dog park.

ALL CHILDREN MUST BE SUPERVISED BY A PARENT NOT COMPETING IN THE TRIALS.

ANYONE OBSERVED NOT PICKING UP AFTER THEIR DOG WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.

AN OFFICIATING JUDGE, AND/OR THE CHAIRPERSON OF THE TRIAL, MAY DISMISSFROM THE TRIAL SITE ANY PERSON SUBJECTING THE JUDGE OR MEMBERS OF THE ORGANISING COMMITTEE TO ABUSE, WHETHER THAT PERSON IS COMPETING IN THE TRIAL OR NOT.

ANYONE OBSERVED DISCIPLINING THEIR DOG IN A MANNER THAT OFFENDS A JUDGE'S SENSIBILITIES WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.
