If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees (\$10.50 including GST) when entering events. The request for a TCN will be self-serve; exhibitors should go to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone.

**GENERAL INFORMATION AND TEST RULES**

**CKC REGULATION:** “It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”

**ELIGIBILITY**

Purebred or mixed-breed dogs must be at least 6 months of age and:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Eligible for registration with the CKC and have a Temporary Competition Number (TCN)
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

Dogs that are eligible for a CKC or ERN number but don't yet have one should have a Temporary Competition Number (TCN). These can be obtained free of charge online from the CKC. For more information about the TCN:

**ENTRY LIMIT:** These Trials are limited. If the tests fill, waiting lists will be kept and dogs from the waiting list may be entered and added.

**Handlers** may only enter **1 dog in each component at each level.** Dogs can only be entered in Open and Excellent if they have already obtained the preceding level title.

**MOVE UPS:** Same day trial move ups will not be allowed. Move ups for the next day's trial are allowed. Exhibitors must already be entered at the current level to move up. **Move ups for SUNDAY'S trial will be accepted at this event, SUNDAY between 8:00am and 8:30am only if space is available.**

**Judging schedules will be sent by email to exhibitors after the closing date**

**The owner of a dog entered in this show is entirely responsible for any errors in the entering of the dog, regardless of how, or by whom the entry was made. Please check your confirmations for accuracy.**

**RIBBONS & AWARDS:**

Flat Ribbons for all Qualifying Scores

Rosettes awarded for Instinct, Novice, Open, Excellent & Masters Titles

Team Charli Award, Judge's choice, Novice Class each day

**LEVELS OFFERED EACH DAY:** Instinct, Novice, Open, Excellent & Masters

**COMPONENTS OFFERED EACH DAY:** CONTAINERS, INTERIOR, and EXTERIOR

**VENUE INFO:** Please be advised that there are stairs (short flight) to enter and exit the building. There will be a set of stairs for one of the testing areas.

**ODOURS BEING TESTED:**

Instinct & Novice	Wintergreen
Open	Wintergreen & Pine
Excellent	Wintergreen, Pine & Anise
Masters	Wintergreen, Pine, Anise & Clove

**EQUIPMENT:** The dog may wear a buckle, snap or martingale collar and/or body harness in the ring. Collars/harnesses with tags may be worn in the ring. Harnesses may have the leash attached to the front clip or on the back. Electronic training and pinch collars are not allowed on the grounds.

**PENALTIES ISSUED BY THE CLUB:** Dropping food while rewarding is considered contamination. Contamination of the search area, at the discretion of the Judge may result in a non-qualifying score. Any dog that urinates or defecates or vomits within the search area will be excused from the class and will result in a non-qualifying score.

**SCENT DETECTION RULEBOOK:** It is up to the individual handler to review the CKC Scent Detection Rulebook prior to the trial. Note: There were changes and updates made to the rulebook July 1 2021.

**REMINDER:** That anyone discussing hides before the end of the trial will be excused and asked to leave as per CKC rules. Please show consideration for other competitors.

**BITCHES IN SEASON:** Bitches in season shall not be eligible to enter the test. If a bitch comes into season after entries have closed, the club will refund the entry fee providing the event secretary receives, on or before the event, a veterinarian's certificate declaring that the bitch was in season within the 7 day period preceding the trial.

**BORDER CROSSING:** A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada. All participants who crossed the border will have done 14 days of quarantine immediately prior to trial date.

**BRING YOUR OWN MASKS**

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. **ATTENTION FOREIGN EXHIBITORS:**

Please note that fees are due and payable in Canadian dollars. Due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

**SITE INFO:**

There is limited parking. Please park in the designated marked area. Allow our committee to help you with a place to park. No special area will be designated for reactive dogs. These trials will be run rain or shine. All dogs must be under control, on a leash except during the trial where off leash searches are permitted. Flexi leads will not be allowed on the trial site. Please, clean up after yourself and your dog.

## Changes to Scent Detection Protocols

The following motion was passed by the CKC Board on September 22nd, 2020 during a Special Board meeting:

“THAT, effective immediately and until the COVID-19 situation is resolved, that the following section of the Scent Detection Trial Rules & Regulations, effective January 1, 2019 be held in abeyance:

6.8.3 The following classes must be offered: Instinct & Novice. And THAT, effective immediately and until the COVID-19 situation is resolved, clubs will be granted the flexibility to offer their choice of classes, elements and height divisions to meet the availability of facilities and comply with local and provincial regulations relevant to size limits of gatherings.”

This motion provides flexibility for clubs holding Scent Detection Trials, allowing them to offer the choice of classes without having to hold Instinct or Novice classes, offer some or all of the various components (Containers, Interior and Exterior), and offer some or all of the various height divisions (Small, Medium & Large) during the COVID-19 Pandemic.

*A reminder that these are temporary policies in place during the COVID-19 pandemic.*

### **ADDITIONAL COVID, TRIAL AND VENUE INFORMATION:**

1. Please adhere to coronavirus health safety measures, including proper physical distancing, wearing a mask, and remaining at home if you show symptoms of cold or flu.
2. Exhibitors will be required to wear Screening Wristband for entire duration of trial.
3. Schedules are based on 2 minutes per dog for Instinct, 9 minutes per dog for Novice and Open, 11 minutes per dog for Excellent, and 12 minutes per dog for Masters.
4. Please allow for absentees and variances in the rate of judging.
5. Please Obey ENTER and EXIT gates in the trial area.
6. No dogs and equipment left unattended at the trial venue.
7. Dogs must be on leash at all times inside the trial venue and trial grounds.
8. Exhibitors will be required to crate their dogs in their vehicle. Please be prepared for weather.
9. There will be NO spectators allowed inside trial venue.
10. Access to trial parking will be allowed on Saturday, March 5th starting at 7:00 am. Please follow posted signage by trial venue and OVOTC. Please park neatly. Please adhere to Fire Lanes in all areas around the venue.
11. Ribbons and rosettes will be set out on a table. If you DO NOT want your ribbon or rosette please leave it on the table, please DO NOT touch it.
12. Masks are MANDATORY in the trial area, the washrooms and when you can't socially distance outside of your bubble.
13. Hand sanitizer stations will be available in the trial area and washrooms. Please bring your own to use when you are at your vehicle.
14. Social distancing MUST be followed while on the show site and in the trial area. Avoid gathering, please.
15. Exhibitors are expected to maintain a clean area. Please be considerate when utilizing any facilities. No dogs are permitted in the washrooms.
16. Bring your own food and drinks, for yourself and your dog.
17. No overnight recreational parking will be provided.
18. Exhibitors and Participants are expected to follow these event guidelines. Failure to comply may result in excusal from the remainder of this event. The club reserves the right to remove any person(s) from the show and the venue, which are governed by CANADIAN KENNEL CLUB (CKC) rules.

- (B) the method of transmission, whether direct or in direct, includes but is not limited to, airborne transmission, bodily fluid transmission, transmission from or to any surface or object, solid, liquid or gas or between organisms.
