ENTRY FEES: \$ 65.00 per dog/ Per Trial /TD \$ 80.00 per dog/Per Trial /TDX

LISTING FEES:\$ 8.50 plus 5% GST per dog/ Per Test

If a dog is not registered individually with the CKC it may be entered at a tracking test as a "listed" dog, provided that:

- (a) If born in Canada, it is of a litter which is eligible for CKC registration
- (b) If not born in Canada, it is eligible for individual registration in the records of the CKC.
- (c) If foreign born and owned, it obtains an Event Registration Number (ERN) or CKC registration number, from the CKC within 30 days of the first test entered.
- (d) It is not a designated Miscellaneous Class Breed.

NON-MEMBER PARTICIPATON FEE: (Effective January 1, 2011)

Policy:

Non-member participation fee

a) An annual fee for awards and titles will be charged to a Canadian non-member of CKC.

The fee will match the ERN fee.

- b) In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled.
- c) All Premium Lists will carry a note stating the fees apply only to dogs wholly owned by non members and is not applicable to CKC members.
- *Please note that the CKC Membership Application and the Non-Member Participation Fee forms are available on the website under CKC Services and then Forms On-line. If submitting a Membership Application, please ensure that you also complete the Non-Member Participation Fee form so that we are aware of the dogs involved.

PRIZES: A ribbon stating "Passed T.D." or "Passed T.D.X." will be awarded to dogs earning these degrees.

<u>NOTE:</u> There will be a \$30.00 service charge on all **NSF** cheques received. Tendering of an **NSF** cheque shall be considered **NON-PAYMENT OF ENTRY FEES** and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

PLEASE BE SURE TO INCLUDE YOUR POSTAL CODE ON THE ENTRY FORM. C.S.D.C.A. WILL NOT BE RESPONSIBLE FOR JUDGING SCHEDULES MAILED WITHOUT THE POSTAL CODE.

There will be complimentary coffee and donuts in the morning. Lunch will be complimentary.

** If the TDX tracks on the Saturday a.m. and the TD tracks on the Saturday p.m. do not fill, we may offer a different track level (up to maximum allowed exchange per CKC rule 6.2.2). Exhibitors may send in an entry and cheque for a chance at a TD track on the Saturday a.m. or for a chance at a TDX track on the Sunday p.m. If the TDX tracks fill on the Saturday a.m. and the TD tracks fill on the Saturday p.m., a refund will be sent within 10 days of the test date.

Entrants will be notified by phone or email that their entry has been received. Withdrawn entries after closing date will only be refunded where there is an "Alternate" available who chooses to fill that assigned entrant's vacancy on test day. Alternates will be contacted in catalogue order and advised of the opening. If they choose to accept the spot, they become responsible for the entry fee or decline it and bear no financial obligation. Anyone on the "alternate list" may request a refund at any time prior to test day. Entry fees will be returned within 10 days of the day of the test to Alternates who did not participate in the test.

Upon receipt of a complaint, the Tracking Test Committee of the test-giving club shall conduct an investigation as soon as possible thereafter, but in any event, within 14 days of receipt, shall conduct a hearing in accordance with the procedure for conducting a Tracking Test Committee hearing as provided in these rules and regulations.

TEST RULES:

- 1. Only dogs entered in the Test will be allowed on the test grounds.
- 2. All dogs must be on leash and under control at all times.
- 3. Bitches in season will be allowed to compete but will draw lots for the last tracks.
- 4. Spectators will be expected to obey any instructions given by the Test Superintendent.

- 5. The Competitive Service Dog Club of Alberta will exercise all reasonable care for the safety of the dogs competing, but will not be held responsible for the loss, damage, or injury to the dogs or handlers and their property.
- 6. There will be NO prong, pinch or electric shock collars allowed on the test grounds.

7. EXHIBITORS MUST BE PRESENT WHEN IT IS THEIR TURN TO RUN THE TRACK. EXHIBITORS THAT ARE NOT PRESENT WHEN THEIR NAME IS CALLED WILL BE DISQUALIFIED.

8. The Competitive Service Dog Club Of Alberta, its members, volunteers and the land owners will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons. By entering this Test each participant agrees to assume all risks and hazards incidental to participation in the Test and agrees to release and to save harmless and indemnify the owner(s) and/or leasee(s) of any property upon which the Test may be held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participants use or entry upon the property. It is understood that this agreement is binding upon the participants, his or her heirs, executors and assigns.
