**Closing date** -8:00 PM May 11, 2018. Entries must be delivered to the Test Secretary by the closing date. The club cannot accept entries delivered after this date and time.

All entries received prior to the closing date will be acknowledged by mail/email and entered in the entry draw. A random draw of all non-duplicate entries will be conducted May 12, 2018 at 8 am at the home of the test secretary. Any interested parties may attend the draw. After all the tracks have been filled, the draw will continue to create a list of alternates in the order drawn.

After the random draw, the club will send out acceptance letters or emails advising entrants of the status of their entry. A map showing directions to the rendezvous site will be provided if necessary. Entries from the Alternate List may fill any absentee spaces up until one hour before the start of the Tracking Test. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

As per Sec 6.6.2, no test tracks will be set aside for Club workers. These tests are open to mixed breeds and unrecognized breeds as per Sec 2.2.4.

**Draw for tracks TD and TDX on May 27, 2018 at 9.00AM** at the rendezvous site, Tim Horton's, 1713 Woodstock Rd, Fredericton, NB **Prizes** –Passing dogs will receive a rosette and suitable prize.

**Entry fees:** \$75.00 TD \$85.00 TDX

**Listing fee** -\$9.80 “A listing fee as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form.”

Fees are payable to: Fredericton Kennel Club. Post-dated cheques will not be accepted. NSF cheques are considered non-payment of entry fees and will be charged a fee of \$25. Please note that fees are due and payable in Canadian dollars. Bank drafts or INTERNATIONAL money orders payable in Canadian funds are acceptable. Your understanding and cooperation is appreciated.

**Withdrawals and Entry Fee Refunds** – If an entry withdraws between the closing date and the test date and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary. Entries will be refunded within ten days of the tracking test to those on the alternate list who did not participate in the test. Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge or barred from competition by action of the Test Committee.

**Bitches in Season** – Bitches in season will be allowed to participate but must run last and must be kept separated from all other dogs during the event.

**\*\*NEW\*\*** An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

Fredericton Kennel Club will use all reasonable care to ensure the safety of dogs and persons at the test. However Fredericton Kennel Club nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

**CKC Tracking Rules (13.7):** It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Tracking Test Committ Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
