DIRECTIONS TO SHEEP THRILLS FARM - Located approx. 15 minutes from Saskatoon.

Head west on 22nd Street and onto Hwy 14. Turn left (south) at the Sandyridge Gas Station onto Young Road. Go 1 mile to the stop sign, turn right (west) onto the paved road. Go about 1 mile; Sheep Thrills is the last place on the right hand side just before the train tracks. An annual non-member participation fee for awards and titles will be charge to a Canadian non-member of the CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

Attention Foreign Exhibitors: ERN numbers must be applied for within 30 days of the first day of entering a CKC event. A CKC ERN registration form can be downloaded from the CKC website: http://www.ckc.ca

Section 15.7 of the CKC Herding Rules states: It shall be the duty and obligation of the trial-giving club to see that a judge, club officer, ring steward volunteer or competitor at a herding trial held under these regulations, is not subject to indignities of any kind. The Herding Trials Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

PLEASE NOTE: There have been many changes to the CKC Herding Rules that took effect July 1,2021. Rule books can be found on the CKC website.
