These events are held under the rules of the "Canadian Kennel Club".

Move-ups between trials on the same day will be permitted.

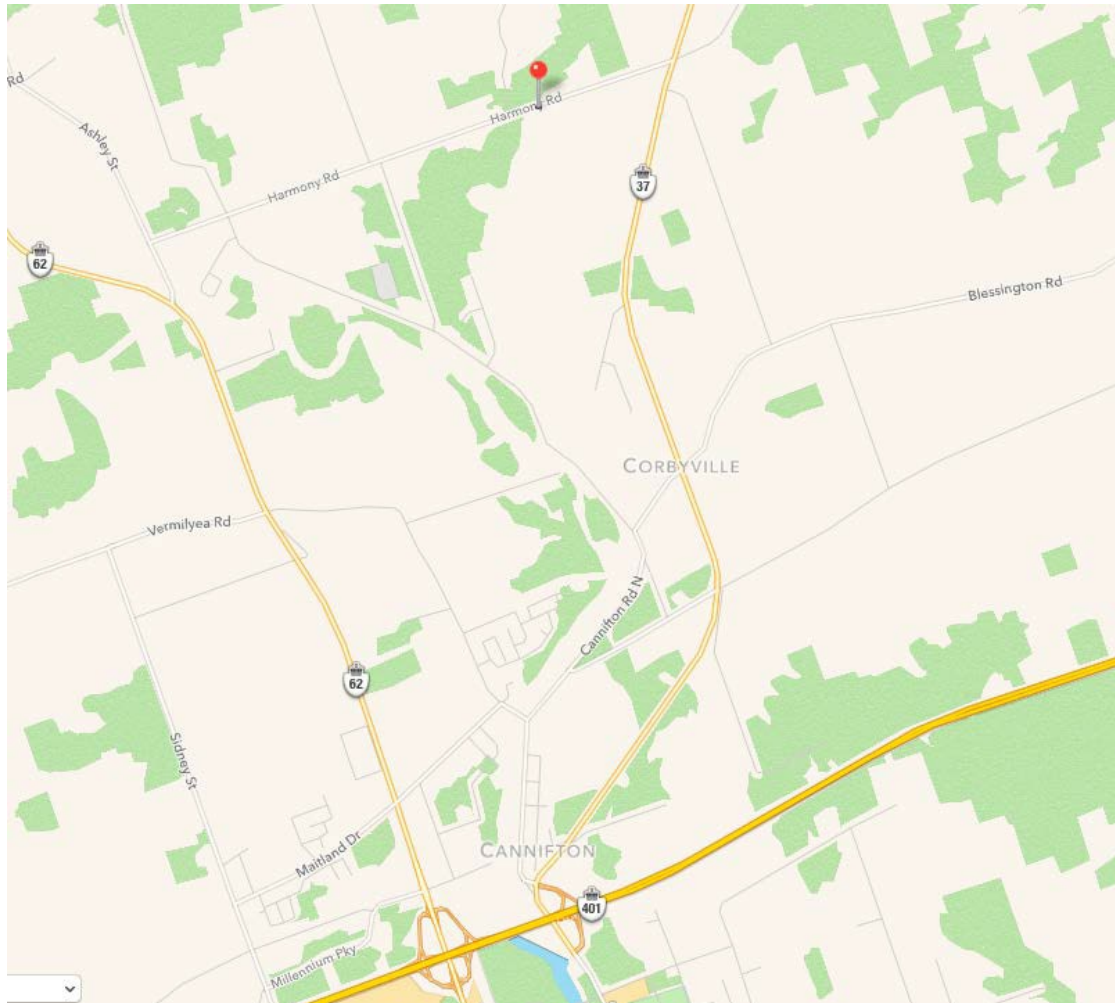

All particulars called for on the entry form must be complete. Any telephone calls required to confirm information will be made COLLECT. Exhibitors must abide by errors made in entering their dog/s regardless of how or by whom the entries were made. No entry will be accepted unless accompanied by full entry fees. The B&DKC cannot accept fax or phone entries and reserves the right to refuse any entry, subject to CKC rules. If because of riots, civil disturbances or acts beyond the control of the Trial Committee, it is impossible to open or complete the trial, no refund of entry fees will be made. All entry confirmation and judging schedules will be e-mailed as soon as possible after entries close.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.

Eligibility: To be eligible to compete in this trial, a dog must be at least 18 months of age and registered with the CKC or eligible for registration with the CKC, have a PEN, an ERN or have a CKC MCN (Miscellaneous Certificate Number) or a TCN. In addition, Mixed Breed with a CCN (Canine Companion Number) may compete.

Bitches in season are not permitted to compete in the trial however, entry and listing fees will be returned, providing a veterinarian's certificate stating that the bitch was in season within the 10- day period preceding the trial is submitted to the Trial Secretary on or before the day of the trial.

Temporary Competition Number (TCN) With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will replace the current system of entering events with "listed dogs", and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN. While there is no fee to obtain a TCN, exhibitors will still be required to pay TCN Fees (formerly called listing fees) when entering events using this number.

TCN fees. A CKC TCN (see below) fee of \$11.30 including HST Can. or US per dog per trial is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, PEN (Performance Event Number), ERN (Event Registration Number), or Miscellaneous Certificate Number (MCN).

For Fun Only (FFO – new) At the owner's discretion, dogs are able to run as For Fun Only (FFO) in any category. The owner is allowed to take their dog into the ring with a toy.

Toys are allowed but the toy must be identified to the judge prior to entering the ring. A maximum course time of 60 seconds will be allotted.

FFO For Fun Only entries must meet all eligibility rules as dogs running for Qualification. FFO run fees are set at \$15.00 per run.

A handler may choose to enter a FFO dog in any class, in any trial, at any performance level and at any jump height. Obstacle repetition is permitted without dismissal. They are not allowed to enter the same class again for a qualifying run. Dogs must attempt to run the course as numbered and are under the same judging criteria as dogs that are running for qualification.

Senior Handlers and Handlers with Disability (*new*) Senior handlers (65 years and over) and handlers with disability may request a modified course time or modified points requirement (PAD) Modified times: Course under 150 yds – subtract 5 sec. Course over 150 yds – subtract 10 sec. Modified points – 3 points added to each PAD run. Proof of age or disability will not be requested. Handler needs to check the S/D box on the entry form. The handler's dog shall be entered at its current competition height and category – the time and points concessions are for the handler.

Exhibitor Conduct “It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred”. (4.1.3 t)

Awards and Prizes: (for qualifying scores, only)

Ribbons: Flat ribbons will be offered for all first to fourth place in each jump height in each class as well as for all qualifying scores.

Rosettes will also be offered for any new title earned at this trial.

Precincts of the trial: All grounds within 100' of the ring area or the fenced area of the grounds, whichever is less, shall be considered the trial grounds. The rings are enclosed by 2 ½ ft high snow fencing. The entry/exit gates are white accordion style, approximately 3” high and are closed during the run.

Walk Through: Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class. At the end of the walk through, an announcement will be made as to when judging will begin. A judge may extend the time allotted from 3 to 5 minutes based on the crating distance from the ring. Judging may begin sooner if the first three dogs of the class are ready and wanting to start. Warm-up jumps will be provided near the ring area.

Move-up option: Dogs may be moved up to the next class between trials on the same day, by filling in the required move-up form.

Exhibitor Information: There are many rule changes for 2020. Exhibitors are advised to read the 2020 rules carefully. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the **CKC Agility Rules and Regulations Effective January 2020**. Check-in will start Friday at 3:30 pm followed by PAD and Jumps and Tunnels 1 &2, Steeplechase. Trial 1 first dog will be on the line at 4:00 pm.

Saturday and Sunday check in begins at 7:15 a.m., with the first dog on the line at 8:00 am.

Equipment familiarization: There will be supervised contact equipment familiarization for Novice Dogs only, each morning before the Novice Std class.

Food: No food during the day is available on the grounds, but available within 5 min. of the trial grounds.

- Novice class is open to dogs that have not acquired an Intermediate leg in the class entered.
- Intermediate class is open to dogs that have acquired the Agility Novice title, and to those dogs which have not yet acquired a qualifying score towards the Agility Excellent title in the class entered.
- Excellent class is for dogs that have acquired the Agility Intermediate title, but have not yet earned a qualifying score towards an Excellent title in the class entered.
- Master Excellent class is for dogs that have acquired the Agility Excellent title in the class entered.

Height Divisions

Handlers are responsible for entering the correct height division. The judge may request any dog be measured. **Selected** Class dogs will jump one height lower than the equivalent regular class height shown in the table below and dogs who measure 10” or below will jump 4” in the Selected Class. **Veteran** dogs may jump one or two heights lower. The following jump height divisions shall be use in all regular classes.

8 inches for dogs 11 inches and under at the withers
12 inches for dogs 14 inches and under at the withers
16 inches for dogs 18 inches and under at the withers
20 inches for dogs 22 inches and under at the withers
24 inches for dogs over 22 inches at the withers

Obstacles:

Agility obstacles meet the requirements of the CKC Agility Rules

Note: A-Frame, Dogwalk, Teeter and Table have rubber surfaces and the tire is a breakaway self-healing type. Six weave poles are in all Novice Classes. There are 12 weave poles in all Intermediate Standard and Jumpers With Weaves. (*new*).

The One Bar Jump may be used at any level. A Frame is set at 5' for dogs jumping 12" or less and for the Steeplechase class and 5'6" for other runs. The Tire is set 4" less than the regular jump height. The Wall Jump or The Broad Jump will not be used.

Electronic timing will be used at these trials. There will be **two rings** running alternately.

Camping

Overnight dry camping allowed at the trial site. No services but water will be available for fill-up. Cost: \$10.00/day. Generators Allowed. Indoor flush toilets available.

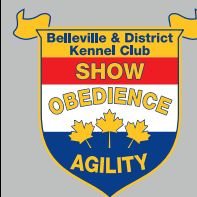
