FACILITIES

This is an indoor facility in Brandon. Limited space for crating indoors is available and there are washrooms and water onsite. Bring your own lunch or take advantage of numerous restaurants/grocery stores within a 10 minute drive.

All dogs must be crated, in an ex-pen, or on leash when not in the ring. Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. We ask that all dogs be exercised in out enclosed area to the back of the building or across the road in the off leash dog park.

ALL CHILDREN MUST BE SUPERVISED BY A PARENT NOT COMPETING IN THE TRIALS.

ANYONE OBSERVED NOT PICKING UP AFTER THEIR DOG WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.

ANYONE OBSERVED DISCIPLINING THEIR DOG IN A MANNER THAT OFFENDS A JUDGE'S SENSIBILITIES WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.
