

# **ADDITIONAL RULES GOVERNING SHOW & TRIALS**

- 1. The Club reserves the right to remove any person from the Show/Trials. The Show/ Trial Superintendent shall have full control of the event which will be governed by Canadian Kennel Club Rules. The Authorities of this show may decline to accept entries and may refuse to receive or may remove any dog from the Show/Trials on account of disease or viciousness.
- 2. No entry fees will be refunded if the Show/Trials cannot open or be completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club.
- 3. The Show/Trial Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss or other misfortune to either dogs, exhibitors or patrons.
- 4. The welfare of an exhibitor's child is assumed to the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children during these Show/Trials.
- 5. The owner of a dog entered in these Show/Trials is entirely responsible for any error in entering his dog, regardless of how or by whom the entry was made.
- 6. Dogs entered in the OPEN CLASS must have a CKC Individual Registration Number, a CKC Event Registration Number (ERN), or for Miscellaneous Breeds a CKC Certification Number. Miscellaneous breeds may compete only at the Novice level as Listed Dogs.
- 7. In the NOVICE A and OPEN A classes no licensed handler, no trainer, nor any person who has previously exhibited a dog through to its UD title in Canada or elsewhere shall be allowed to compete as an exhibitor in these classes. One dog only may be entered in these classes by any one exhibitor, and every dog must be handled by its owner or a member of the immediate family. A dog which has earned its CD or CDX in the USA, Bermuda or a comparable degree in any foreign country is not eligible for entry in the "A" Classes. Such dogs must be entered in the "B" Classes.
- Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds. All dogs must be kept on leash except when in the obedience ring.
- 9. Exhibitors are responsible for cleaning up after their dogs. Dogs are to be exercised in DESIGNATED AREAS only.
- 10. Any dog excused by the Show/Trial Chairman or the Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the Show/Show/Trials.
- 11. Obedience Only Full refund of entry and listing fees will be made for a BITCH that comes into SEASON after the close of entries if a veterinarian's certificate is presented to the Trial Secretary at least ONE HOUR BEFORE the start of the TRIALS.
- 12. Any person, either within or outside the judging ring, who does anything calculated to attract of distract or otherwise affect in any way the attention, or department, or performance of a dog under judgment, may be disciplined by the Discipline Committee in whatever way it considers in the best interests of the Club, or the Judge may take summary action.

Exhibitors are expected to know the Canadian Kennel Club Dog Show and Obedience Rules. Copies may be obtained from the Canadian Kennel Club,

For dogs at least 6 months of age on the first day of the show and under 9 months of age on the first day of the show.

#### Senior Puppy

For dogs at least 9 months of age on the first day of the show and under 12 months of age of the first day of the show.

#### 12-18 Months

For dogs at least 12 months of age on the first day of the show and under 18 months of age on the first day of the show

#### Canadian Bred

For dogs born in Canada. Champions of any country excluded.

#### **Bred By Exhibitor**

For dogs owned and handled in the ring by the breeder.

#### Open

For all dogs.

#### Veterans

For dogs at least 7 years of age on the first day of the show.

#### Specials

For dogs who have earned all of the Championship points required for Championship status.

# Moving Dogs to Specials

A dog which is individually registered in the records of the CKC, and has completed requirements of a Championship, after the closing date for entries, may be transferred from a regular class to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in **WRITING** at least one hour prior to the opening of the show (not just prior to class judging), by the owner or handler.

#### **Obedience Classes & Awards**

#### Novice A

For dogs which have not won the title of C.D. (Companion Dog) in any country.

#### Novice B

For dogs which have not won the title of C.D. (Companion Dog) in Canada.

#### Open A

For dogs which have won the title of C.D. (Companion Dog) in Canada, but have not won the title of C.D.X. (Companion Dog Excellent) in any country.

# Open B

For dogs which have won the title of C.D. (Companion Dog) in Canada. A dog may continue to compete in this class after having won the title of C.D.X. and/or Utility Dog.

# Utility

For dogs which have won the title of C.D.X. in Canada. A dog may continue to compete in Utility Class after having won the title of Utility Dog.

#### Novice C

For dogs which have earned the title of Companion Dog, Companion Dog Excellent, Utility Dog, and any other advanced obedience title in Canada.

# Not eligible for High In Trial.

In Novice A and Open A one dog only may be entered in the classes by any one exhibitor, and every dog must be exhibited by the owner or a member of his immediate family. No licensed handler, no trainer, nor any person who previously exhibited a dog through its U.D. Title in Canada or elsewhere shall be allowed to compete as an exhibitor. If any exhibitor enters more than one dog in Novice B or Open B classes, each dog must have a separate handler for the sit and down exercises.

Qualifying Scores Only

The GSD Obedience Victor or Victrix award is given to the male GSD or Female GSD (but not both) with Highest Combined Score in Open and Utility in any one of the four trials. The dog must have won (and be able to show proof of) a blue ribbon at an AKC or CKC conformation show. If dog doesn't have a blue ribbon, 2 conformation judges judging the conformation at the National will be brought into qualify the dog's conformation.

#### **Entries Limited**

Total obedience entries will close when the judge's assignment has reached 3.5 hours of judging for each trial based on the formula of 8 Novice. 7 pen and 6 Utility per hour.

# **Perpetual Trophies**

All perpetual trophies will remain in the possession of the German Shepherd Dog Club of Canada Inc. and the names of the winning dogs will be inscribed on the trophies each year.

# **Obedience Ring**

Obedience Ring will be indoor in the Coverall at the Agriplex in Cloverdale.

# **Futurity/Maturity Finals**

Will be held on Thursday, September 8, 2011 at 6:00 PM. These classes are open to the Futurity Male & Female; Maturity Male & Female, Reserve Futurity Male & Female and Reserve Maturity Male & Female in the six regional Futurity/Maturity shows during 2011. Entry is automatic and no charge


