Please note new C.K.C. Ruling – non -CKC members who are Canadian, running a wholly – owned dog, cannot win a placement unless they pay a non-member fee to the CKC. Otherwise, awards & titles will be cancelled.

ENTRIES: Please complete one entry form per dog, per stake, per day, you wish you enter your dog(s). All entries must contain complete information as required by the CKC rules. All entries must be accompanied by the entry fee in full and all applicable listing fees. A listing fee of \$11.30 must be submitted for any dog without an individual registration number.

Entry fees in the All Age stakes include a \$5.00 fee imposed by the NRCC to help finance the National Open stakes in Canada. This money will be directed entirely to the hosting clubs in an effort to keep these stakes financially feasible.

Our closing date will be on Sunday, June 16th, 2024 at 6:00 pm.

We will utilize the 2 ending digits in the TSX as of close of business on Wednesday June 19th, 2024 as a starting number for the first series in the All Ages Stakes. Judges will impose a system of rotation thereafter in the All Age stakes. Judges may impose a rotation in the minor stakes at their discretion.

A rotation of starting order between series will occur in all stakes.

The North Bay & District Retriever Training Club is a member of the National Retriever Club of Canada. Dogs entered in all age stakes may qualify for the National Stakes.
